Sub: Correction in particulars of the Online Application Form of UGC-NET December 2022.

In view of the numerous representations received from the candidates regarding giving them an opportunity to edit/modify their particulars in the Online Application Form of UGC-NET December 2022, National Testing Agency(NTA) has decided to provide the opportunity to the candidates for modifying their particulars in the Online Application Form of UGC-NET December 2022. The schedule for the same are as given below:

*Vide Corrigendum dated 05.01.2023, NTA has carried out the necessary modification in the age criteria as 01.12.2022 instead of 01.02.2023. In this regard, it is informed that those candidates who have already applied for December 2022 UGC-NET only for Assistant Professor instead of Both (Assistant Professor and JRF) may also modify **apply for** in their online application form. Hence, correction facility is available in 'apply for, category, Qualification, Pwd, Research & Ex-Serviceman'.*

All the registered candidates for the said Examination are advised to visit the website and verify their particulars. They are further advised to make correction/s in their particulars, in their respective Online Application Form, if required, as per **Annexure-I**

The candidates are allowed to make the corrections, **latest by 20 January 2023 (up to 11:50 P.M.)**. Thereafter, no correction in particulars, whatsoever, will be entertained by NTA under any circumstances. The additional fee (wherever applicable) shall be paid by the candidate concerned either through **Credit/Debit Card/Net Banking and UPI**.

Since, it is a one-time facility extended to the candidates to avoid any hardship to them, the candidates are informed to do the correction carefully, as no further chance for correction will be given to the candidates.
