

- 2. The quantity can be increased or decreased depending upon the availability of work.
- 3. All rates quoted by Contractor/Firm/Agency/Society shall include all type of Taxes.
- 4. The estimated cost of one RCC Fencing Post (Pillar) of 342/- (including all type of taxes).

- 2. In order to strengthen the RCC Pillars, each pillar should be dipped in water for minimum 3 days and then continuous water curing for minimum 10 days.

- 1) The Applicants/bidders have to complete 'Application/Bid Preparation & Submission' stage on scheduled time as mentioned above. If any Applicant/bidder failed to complete his/her aforesaid stage in the stipulated time schedule for this stage, his/her Application/bid status will be considered as 'Applications/bids not submitted'.
- 2) Applicant/Bidder can rework on his/her bids even after completion of 'Application/Bid Preparation & submission stage' (Application/Bidder Stage), subject to the condition that the rework must take place during the stipulated time frame of the Applicant/Bidder Stage.

Instructions to bidder

These conditions will over-rule the conditions stated in the tender documents, wherever relevant and applicable.

1. Registration of bidders:-

New bidders intending to participate in the tender's process please deposit a sum of rupees 2000/- +18%-GST = 2360/- (Rs. Two Thousand Three Hundred Sixty only) in the shape of Demand Draft in favour of GM, HFDC Ltd., Karnal payable at Karnal.

2. The registration Certificate is issued upon receipt of mandatory identity (i.e. Applicant's PAN Card) and Address proofs and verification form duly attested by the Bank Manager/Post Master/Gazetted Officer. Only upon the receipt of the required fees.



Terms and Conditions

- 1. Tender Application Forms, terms and conditions and e-tendering schedule can be downloaded from the Haryana Government website http://etenders.hry.nic.in on payment of prescribed Tender Fee and e-services fee. The cost of tender forms once paid is not refundable on any account, nor will the amount be adjusted towards cost of any other tender forms
- 2. If bid receiving/opening day happens to be a holiday, bids will be received/opened on the next working day at the same time and venue.
- 3. The first requirement to participate in tender is to have registration of tenderer with Haryana Forest Development Corporation Ltd., Karnal
- 4. The validity of bid is **31-03-2025** from the date of opening.
- 5. The General Manager reserves the right to accept or reject any or cancel any or all the tenders without assigning any reason thereof.
- 6. In case the tenderer/bidder has any doubt about the meaning of anything contained in the tender document, he shall seek clarification on any working day during office hours from the office of General manager HFDC ,Forest Complex , Near Railway Station (Karnal).
- 7. The tenderer/bidders are expected to examine all instructions, Technical specification, Drawing, terms & conditions mentioned in the tender document before participation in the tender.
- 8. Before submitting the tender the tenderer is advised to visit the area/site of work to study all the field conditions and nature of work and quote his rate accordingly. No enhancement in rate due to any reason will be entertained thereafter.
- 9. The bid of the bidder, who does not satisfy the qualification criteria in the bid documents, are liable to be rejected summarily without giving any reason and no claim whatsoever on this account
- 10. The quantities of work shown in the tender document are approximate and it may vary during actual execution of work depending upon the availability of work order to HFDC.
- 11. It shall be open to the General Manager to cancel/reduce the quantity of work to be executed based on availability of work order and the General Manager's decision will be binding on the contractor. Participation in the online bid shall amount to bidder's acceptance of the terms and conditions of the tender.
- 12. The Contractor/Firm/Agency/Society should have experience of manufacturing of RCC Fencing Post (Pillar) or civil works given in the tender for Government Department/organizations/Agencies.
- 13. The RCC Fencing Posts (Pillars) shall be manufactured as per specifications and drawing attached as **Annexure-I and Annexure-II** respectively in DNIT.
- 14. RCC Fencing Posts (Pillars) shall be manufactured only in Workshop under HFDC Karnal or on the place/shed/premises provided by GM HFDC Karnal.
- 15. In case the tenderer quoting different total amount in words and figures also, lower of the same will be considered valid and shall be binding on him/her.
- 16. Canvassing or negotiation, direct or indirect, would render the tender liable for exclusion from consideration.
- 17. The lowest tender will ordinarily be accepted, but the authority competent to accept the tender reserves to himself the power of accepting or rejecting any tender without assigning any reason thereof and can also any time by notice in writing to the bidder(s) terminate the tendering process.
- 18. If the lowest bidder fails to sign agreement within stipulated period of time, the offer will be given to second lowest bidder. The Earnest Money of L-1 will be forfeited.
- 19. All the corrections in the tender form shall be initiated by the tenderer himself. The tenderer shall submit the filled up tender form together with all pages intact duly signed by the contractor himself or his/her authorized representative.
- 20. The tenders submitted by tenderer shall remain valid for acceptance for a period of three months from the date of opening of the tender. However this period can be extended with the consent of both parties.

- During the said period of three months or the extended date as the case may be, the tenderer shall not be entitled to revoke or cancel his tender or to vary the tendered rates given or any terms thereof, without the written consent of the Haryana Forest Development Corporation Limited.
- 21. The authorized representatives of Tender Committee headed by G.M. HFDC Karnal will open the bid in the presence of the Tenderers/Bidders or their representatives who choose to attend at the appointed place and time. The qualification for the technical bid shall be based on the online receipt of all the documents required on or before the closing date and time of bidding. Financial Bids/Price Bids of only the technically qualified bidders will be opened for evaluation.
- 22. The tenderer whose tender is accepted will be informed regarding acceptance of his tender by a Confirmation Order/Award letter at earliest. The successful tenderer within ten days after issuing of confirmation/Award letter for his tender shall have to execute an agreement in the prescribed form on a proper non-judicial stamp paper (worthRs.100/-) to be supplied by him at his cost failing which the acceptance of his tender shall be considered as withdrawn and the EMD submitted by the tenderer shall stand forfeited to the Haryana Forest Development Corporation Limited. A further period up to 10 days shall be allowed by the General Manager for signing agreement if the successful bidder is able to furnish sufficient justification for delay.
- 23. Bid securities (EMD) of the unsuccessful Tenderer/Bidder will be returned at the earliest.
- 24.On completion of contract period, the security deposited shall be refunded within 20 days without any interest after the successful completion of the contract work and on producing the Non Liability Certificate from the concerned officer.
- 25. The successful tenderer herein after referred as the "contractor" shall start execution of work after signing the agreement in the prescribed form (Attached as Annexure-VII) and on receiving the work order from time to time as may be required. He/She should complete all works as per the prescribed time schedule and the specifications and directions given by the officers of the Haryana Forest Development Corporation Limited from time to time.
- 26. The period of contract shall **be up to 31/03/2025.** The Haryana Forest Development Corporation Limited may also short-close the contract in case of non-availability of work. The HFDC is not bound to pay any compensation in such cases.
- 27. In case the contractor defaults or withdraws from discharge of the work order before its completion, no payment even for the partly executed work shall be made besides his contract security shall also be forfeited.
- 28. In case the work is abandoned mid-way, all the bills due to the contractor will be impounded and EMD as well as Security Deposit will be forfeited. The Haryana Forest Development Corporation Limited will make necessary arrangements to carry out balance work at the risk and cost of the contractor.
- 29. The Tender issuing authority may terminate the work order if it is found that the contractor is blacklisted on the previous occasions by any of the Government Departments/Institutions/Local Bodies/Municipalities/Public Sector Undertakings etc. and all the amount paid for subject work with damages, if any, will be recovered from the Bidder.
- 30. Contractor should employ or engage his own workmen and should strictly abide by all requirements under the Labour Legislation in force from time to time including the payment of Wages Act, the minimum Wages Act, Industrial Disputes Act, Employees' Provident Fund Act, Workmen's Compensation Act, the Contract Labour (Regulation and Abolition) Act etc. Contractor should comply with the provisions of Employees State Insurance Act and Employees Provident Fund, Miscellaneous Provisions Act. And other relevant Statutes as applicable in execution of the work and shall be responsible for making payment of compensation, if any, to any workman during execution of the contract.
- 31. Contractor should apply and obtain the License prescribed under the Contract Labour (Regulation and Abolition) Act 1970 and rules there under within one month of the award of the contract, provided the contractor employs more than twenty workers on any day.
- 32. The HFDC shall not be responsible for payment of any compensation on account of any loss caused

- to the tenderer due to natural calamities or other supervening impossibilities.
- 33. The contractor shall be fully responsible for the omissions and commissions of the labourers engaged by him in connection with the execution of the work. The Haryana Forest Development Corporation Limited will not undertake any responsibility of the labourers engaged by the contractor
- 34. No extension of the period of the contract shall ordinarily be granted. However, if the delay in completing the work within the period specified is due to circumstances beyond the control of the contractor, extension of time may be granted by the General Manager.
- 35. In no circumstance, the successful bidder would be allowed to sublet the works in part or whole of the contract, assigned to him.
- 36. On the expiry of the period of the contract, all rights of the contractor shall cease absolutely.
- 37. The General Manager will have full rights to issue any clarification regarding the interpretation at any of the terms or conditions in the interest of better execution at work and the same will be binding on the contractor.
- 38. The Contractor shall be responsible for the safety of all activities on the Site.
- 39. All risks of loss of or damage to physical property and of personal injury and death which arise during and in consequence of the performance of the Contract are the responsibility of the Contractor.
- 40. The final payment of the tenderer will not be paid until and unless he furnishes Test Certificates (Annexure-IV), Bills/Receipts (Annexure-V) and Acknowledgement (Annexure-VI) from the concern Divisional Forest Officer (to whom RCC Fencing Posts Supplied) to the General Manager HFDC Karnal.
- 41. In case of any dispute between the General Manager, and the contractor on any matter arising out of the contract, the decision of the General Manager will be final the contractor may, within two months of the date of the order of the General Manager appeal to the Chief General Manager whose decision thereon shall be legally binding on the both parties.
- 42. All disputes arising out of the execution of the agreement shall be subject to the jurisdiction of the Court at Karnal.


