## TERMS AND CONDITIONS OF EMPANELMENT

1. **Validity Period:** This empanelment shall be valid for a period of **Two (02) years** from the date of this order, extendable for a further period of one year at a time at the discretion of HFDC.
2. **Scope of Services:** The empaneled entities may be engaged for consultancy assignments related to forestry, environment, biodiversity conservation, ecological assessments, environmental impact studies, forest surveys, biodiversity mapping, and other allied sectoral activities as may be required by HFDC.
3. **General:** No Office space, Office equipments will be provided by HFDC to the empaneled Companies/ Agencies.
4. **Process of award of work:** At the time of resource requirement, HFDC on behalf of a Department/Govt. organization, will issue their scope of work to the empaneled companies/ agencies. Empaneled companies/ agencies will be required to submit their proposals for performance of environment/ecology/forestry related assignments/activities, without any increase during the contract period. Further HFDC in consultation with the respective Department/Govt. organization may select the suitable proposal from the empaneled agency as per of the requirement of the project. Rates for the project/assignments so received from the selected bidder will be opened and negotiated by HFDC before finalizing the agency to ensure that the negotiated rates are according to the quality of the project/assignments.
5. **No Automatic Right to Work:** Empanelment does not confer any automatic right to award of consultancy assignments. HFDC reserves the right to engage empaneled entities based on specific requirements, technical suitability, and prevailing procurement norms.
6. **Assignment Selection:** For specific consultancy assignments, HFDC may invite quotations/proposals from empanelled entities or select entities based on technical competence, experience, and cost considerations as per applicable guidelines.
7. **Compliance Requirements:** All empanelled entities shall maintain their registration, licenses, and certifications valid throughout the empanelment period and comply with applicable statutory requirements.
8. **Performance Standards:** Empanelled entities shall maintain professional standards and deliver quality services as per agreed terms. HFDC reserves the right to review performance and take appropriate action, including de-empanelment, in case of unsatisfactory performance.
9. **Confidentiality:** All empanelled entities shall maintain strict confidentiality of information accessed during the course of assignments and shall not disclose the same to any third party without prior written consent of HFDC.
