Office Memorandum

In order to saturate the electrification of identified habitations/households (HHs) and public institutions of Tribal population as per Ministry of Tribal affairs (MoTA)/State list in the State of Uttarakhand under RDSS, as envisaged by Ministry of Power (MoP) and MoTA, 1 kW electricity connection to be provided to identified households through grid. Division wise details of sanction received vide 47thMCM of RDSS, MoP dated 21.03.2025 is given below:

In order to expedite saturation of sanctioned HHs (work) the distribution circles/divisions of UPCL are authorized to take up this work in a following manner:

- Meter and Cable connections will be released on immediate basis. IT cell of UPCL will create the DAJGUA scheme window for electrification of HHs in NSC module in order to have a provision of zero initial security for these connections.
- 2) As the task of UPCL is to provide connectivity up to the meter, no service connection charge and security is required to be deposited by the consumer/beneficiaries.
- 3) Cost of service cable is available within the sanction under RDSS while cost of meter will be borne by UPCL.
- 4) In areas where smart meters are already sanctioned new connections under DAJGUA shall be released through smart meter.
- 5) The work of HT/LT extension, where ever required will be taken up by divisions in their existing NSC tenders. Where ever necessary circles/divisions are hereby authorized to call for NSC tenders against the sanctioned estimates for this work.
- 6) As the process will be mapped in NSC module divisions will be getting the material for this work from UPCL stores through the normal process of RAPDRP/ERP system.
- 7) Target date for divisions to finish the work of electrification of identified HHs under DAJGUA is 31.07.2025.
- 8) Any new identified Scheduled Tribes (ST) HHs during the implementation shall also be provided connections with intimation to this office provided that the expenditure involved in the electrification should be within RDSS norms i.e. infra cost ceiling of Rs. 2,75,000.00 per village and ceiling of average cost of grid electrification per household of Rs, 42,500.00 in PE habitation at utility level.

- 9) After completion of work divisions will share; a) as executed estimates of expenditure, b) beneficiary list with requisite details, c) photographs of beneficiaries in-front of meter along with coordinates of latitude & longitude, d) meter sealing certificates) payment details of work executed along with copy of measurement, to Electricity Project Payment Division (RDSS) which will further compile the reports and forward to for further action of disbursement under RDSS from MoP/Nodal Agency, M/s PFC.
- 10) Please make a note that this is a social welfare scheme of Govt. of India therefore the concerned officers/officials must ensure their personal attention and sensitivity towards delivery of required service with respect to extension of benefits to all the concerned beneficiaries. Secretary (Social Welfare), GoU in his meeting of 29.04.2025 clearly stated the any slackness in this regard shall be viewed seriously and may call for unpleasant action against delinquents.
- 11) HHs which not got sanctioned due to high cost as per RDSS norms shall have to be taken up through GoU funding as per decision of DRC therefore timely completion of works sanctioned under RDSS will be necessary for estimation of further requirement of infrastructure in this regard.
- 12) Division wise sanction details and the list of beneficiaries (as provided by divisions) is being shared separately.
- 13) This order is being issued after approval from the competent authority.
