I. COMPANY PROFILE

Power Finance Corporation (PFC) was incorporated on 16.07.1986 with the objective to provide financial resources and encourage flow of investments to the power and allied infrastructure sectors; to work as a catalyst for optimum utilization of available resource and to mobilize financial resources from domestic and international sources at competitive rates.

PFC is a schedule A Maharatna CPSE in Financial Services sector under the administrative control of Ministry of Power. Its Registered and Corporate Office is in New Delhi.

The company employed 539 regular employees (Executives 525, Non-executives 14) as on 31.03.2025.

The authorized and paid up capital of the Corporation was Rs. 11,200 crore and Rs. 3,300.10 crore respectively as on 31.03.2025.

The Shareholding of the Government of India is 55.99%.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Projects) is a member of the Board of Directors of the Corporation and reports to the Chairman & Managing Director. He assists CMD towards achievement of corporate vision and goals of the organization. He is responsible for developing and enforcing sound strategy for effective marketing of products to carry out the lending operations, encompassing techno-commercial appraisal of projects identified and ensuring sound and effective follow-up mechanism

to timely implementation of projects financed, thus ensuring adequate return on investment.

III. ELIGIBILITY

The applicant should be a graduate in engineering with good academic record from a recognized University/ Institute. Applicants holding MBA/ Post Graduate Diploma in Management will have added advantage.

4. EXPERIENCE:

The applicant should possess adequate technical/ operational/ project management experience at a senior level of management in a large organization of repute, out of which at least five years during the last ten years should have been in planning/ appraisal/ monitoring/ evaluation/ implementation of projects.
