

Sub: - Filling up the post of Member [Law] of the Kerala State Electricity

Regulatory Commission- Applications invited.

In exercise of powers vested in Section 85 of the Electricity Act, 2003, the competent authority has directed the undersigned to notify a post of Member [Law] in the Kerala State Electricity Regulatory Commission.

Section 84(1) of the Electricity Act 2003 provides as follows:-

The Chairperson and the Members of the State Commission shall be persons of ability, integrity and standing who have adequate knowledge of, and have shown capacity in, dealing with problems relating to engineering, finance, commerce, economics, law or management.

As per para 114 of the judgement of the Hon'ble Supreme Court dated 12.04.2018 in Civil Appeal No. 14697 of 2015, "It is mandatory that there should be a person of law as a Member of the Commission, which requires a person who is or has been holding a judicial office or is a person possessing, professional qualifications with substantial experience in the practice of law, who has the requisite qualifications to have been appointed as a Judge of the High Court or a District Judge". It was further

Those who are now working in State/Central Government. Autonomous bodies, judicial positions etc shall submit their application through proper channel subject to provision of section 84 of the Electricity Act 2003.

Applications forwarded otherwise and belated applications will not be considered on any ground. No enquiry regarding the applications will be entertained. Formal appointment will be made by the Government from the panel/select list recommended by the Selection Committee.
