Subject: Service of Notice in pursuance of directions dated 16.02.2026 passed by the Hon'ble High Court of Uttarakhand in Writ Petition (S/B) No. 244 of 2025 (Anuj Agarwal & Others Vs. State of Uttarakhand & Others) and connected matters being WPSB No. 241 of 2025 & WPSB No. 255 of 2025.

Sir / Madam,

Please take notice that the above-referred Writ Petitions have been instituted before the Hon'ble High Court of Uttarakhand challenging the final seniority list of Assistant Engineers (Electrical & Mechanical) for the year 2008-09, issued vide Office Memorandum / Corporation Order No. 2608 dated 04.06.2025 by Uttarakhand Power Corporation Limited.

On the hearing held on 16.02.2026, the Hon'ble Division Bench of High Court of Uttarakhand Nainital was pleased to observe that notices had not been served upon several private respondents / affected employees whose rights / seniority / promotion prospects may be impacted by the final adjudication of the petitions. In strict compliance with the aforesaid directions of the Hon'ble Court, this notice is hereby served upon you through Uttarakhand Power Corporation Limited.

Copy of the Writ Petitions, along with its annexures and copy of the orders are attached herewith as described hereunder. The Hon'ble High Court has fixed the matter for **final hearing** on 26.02.2026. You are at liberty to file your counter-affidavit / reply / written statement / application for intervention (if so advised), and appear through counsel or in person, before the Hon'ble High Court on or before the said date of hearing i.e., 26.02.2026.
