FREQUENTLY ASKED QUESTIONS
(B.TECH. FIRST YEAR)

- 1. I qualified in JEE (Main) 2025, and I am interested in taking admission in MMMUT Gorakhpur. Do I need to register on counselling portal?**

Answer: YES. It is mandatory for the candidates to register through the official MMMUT 2025 online counselling portal (<https://mmmut.admissions.nic.in/>) to be able to obtain seats to be allocated through centralized seat allocation process of online counselling. (For detailed please refer to section:1 of Undergraduate Admission Brochure 2025-26).

- 2. I locked my choices but now I would like to make further changes to my choice list. Is it allowed? If yes, how can I exercise the option?**

Answer: If you wish to edit your choices after locking but before the first seat allotment, you can do so by first submitting a request to unlock the choices through the online counselling portal.

- 3. Choice filling deadline is already over. Am I allowed to make any changes in my choice list at this point?**

Answer: NO. You will not be allowed to edit your choice list after the deadline for choice filling, i.e. you cannot change the order of your choices OR add any more course in OR delete any course from the choice list after the deadline for choice filling. For more details, please refer to Step-6 of Clause 2.8 of Undergraduate Admission Brochure 2025-26 for detailed guidelines.

- 4. I saved my last filled choice list but I forgot to lock them. Now the choice filling deadline is over, and I cannot make any further changes. Will this affect the list of choices that will be considered for allocating a seat to me during the counselling of MMMUT Gorakhpur?**

Answer: If you do not lock your choices, the last saved choices will be locked automatically upon reaching the deadline for choice filling. The automatically locked choice list will be considered as final choice for allocating a seat during seat allotment.

- 5. I got allocated a seat in a certain round of counselling for the first time, but I am not interested in this seat. I would like to wait for further rounds of counselling to possibly get a better seat in my preference order. Do I need to do anything in the current round?**

Answer: If you are allocated a seat in a certain round of counselling, you need to follow

the steps for online counselling procedure that includes **(i) willingness to FREEZE or FLOAT, (ii) deposition of seat acceptance fee.** You need to accept the seat and choose an option of **FREEZE or FLOAT.** If you wish to be considered for a seat of higher preference in the subsequent rounds (other than the last round), you should choose the option of **FLOAT.** If you fail to complete the above steps, your allocated seat will be **CANCELLED**, and you will no longer be able to participate in the seat allocation process. For more details, please refer to Clause 2.8 of Undergraduate Admission Brochure 2025-26.

- 6. I was allocated a seat in one of the previous rounds and now I have been allocated another seat of higher preference in my choice list. Can I go back to the seat allotted to me in the previous round?**

Answer: NO. Once you are allocated a seat of higher preference based on your FREEZE or FLOAT option, your accepted seat from the earlier round will be automatically cancelled and you cannot get the previously allotted seat.

- 7. I got allocated a seat of my preference in my choice list in a certain round and I am satisfied about the allotted program. I do not want to participate in further rounds of seat allocation. What should I do to keep the allocated seat?**

Answer: If you are satisfied with the allotted seat and do not wish to participate in further rounds of seat allocation, you need to choose the option “**FREEZE**” while accepting the seat and complete all the steps of online counselling procedure.

- 8. I was allocated a seat in one of the previous rounds and I had chosen the option of FREEZE for the choice of academic program for subsequent rounds. Can I change my option to FLOAT in a subsequent round?**

Answer: NO. You cannot change the option to FLOAT if you choose the option FREEZE while accepting the allocated seat. Further, you will not be considered for seat allocation in subsequent rounds (if any) of counselling while your accepted seat remains allocated to you.

- 9. Will there be any spot round of seat allocation after the completion of all the rounds of seat allocation?**

Answer: There will be physical spot round if any vacant seats are available after all the regular rounds of seat allocation.

- 10. Can a student change the branch in B.Tech. before the start of second year?**

Answer: It is possible for a student to change the branch before the start of 2nd semester based on JEE (Main)-2025 rank.

- 11. What is TFW?**

Answer: It is Tuition Fees Waiver Scheme. Sons or daughters of parents whose annual income is less than Rs. 8 lakhs from all sources in the same financial year.

- 12. Is Domicile Certificate Compulsory for the admission of Home State candidate?**

Answer: Domicile certificate of Uttar Pradesh is compulsory only for those candidates whose qualifying examination is **other than Uttar Pradesh**. The domicile certificate of Uttar Pradesh should be in the name of the **parents only**.

13. Is Domicile Certificate required for the admission of Other State (Other Than Uttar Pradesh) candidate?

Answer: Yes. Domicile certificate of **Other Than Uttar Pradesh** is compulsory only for admission of Other State (Other Than Uttar Pradesh). The domicile certificate should be in the name of the **parents only**.

14. What is the counselling procedure for B.Tech. First Year?

Answer: The complete details of the counselling procedure for B.Tech. First Year admission is given in Clause 2.8 of Undergraduate Admission Brochure 2025-26.

15. Will the closing ranks be the same as last year?

Answer: This can't be predicted by anyone. For personal reference, one can check last year's OR-CR on the counselling portal.

16. I have paid Seat Acceptance Fees Online and there is multiple payments. Shall I get the refund?

Answer: The University shall keep only one successful transaction and the other shall be refunded to the source, at the request of the candidate.

17. What should be the date of issue for the category certificate, income certificate, and domicile certificate?

Answer: The date of issue for OBC category certificate, EWS category certificate and income certificate should be 1th April 2025 onwards. Also, there is no restriction on the date of issue of SC/ST category certificates and the domicile certificate.

Answer: The consequences of failing to upload documents or pay the confirmation fee within stipulated time will lead to cancellation of candidature/provisional allotment letter of candidate for subsequent round of counselling. After that candidate can only participate in Spot Counselling.

9. How is the merit list prepared for B.Tech. Second Year (Lateral Entry) admission?

11. What happens if a submitted document is found to be false?

Answer: If any document/declaration submitted by the candidate is found to be false at any stage, his/her candidature for admission shall be cancelled and he/she will be liable for prosecution under the law. In case of any legal dispute regarding admission, the jurisdiction will be limited to Gorakhpur courts only.

12. Can a candidate whose Diploma results are awaited apply for counselling?

Answer: The eligibility of candidates awaiting Diploma results to apply for counselling. However, the candidates in respect of whom the result of the qualifying examination are awaited has to produce original marksheet latest by September 30, 2025, failing which their allotted seat will be cancelled and fee will be forfeited.

18. What is registration fees for B.Tech. Second Year (Lateral Entry)?

Answer: Rs. 2,500.

19. Can I withdraw admission after paying the confirmation fee?

Answer: Yes, the candidate can withdraw his/her admission after paying the confirmation fee. The fee will be refunded after as per fee refund policy of university available at link- https://www.mmmut.ac.in/ug_admission

20. I have locked my choices but now I would like to make further changes to my choice list. Is it allowed? If yes, how can I exercise the option?

Answer: You are required to give **willingness to FREEZE or FLOAT and deposit the seat acceptance fee** for getting better branch in further round of counselling. If you fails to complete the above steps, your allocated seat will be **CANCELLED**, and you will no longer be able to participate in the seat allocation process of subsequent rounds.

24. I was allocated a seat in one of the previous rounds and now I have been allocated another seat of higher preference in my choice list. Can I go back to the past seat allotted to me in the previous round?

Answer: NO. Once you are allocated a seat of higher preference based on your preference order, your past seat of the previous round will be automatically cancelled and you cannot get the previously allotted seat.

25. I got allocated a seat of my preference and I am satisfied with the allotted seat. I do not want to participate in further rounds of seat allocation. What should I do to keep the allocated seat?

Answer: You need to “FREEZE” your seat by login to counselling portal.

26. I was allocated a seat in the previous round, and I had chosen the option of FREEZE. Can I change my option to FLOAT in a subsequent round?

Answer: NO. Once you choose the option FREEZE you will not be able to change it FLOAT in subsequent round of counselling.

27. Will there be any spot round after the completion of all the rounds of seat allocation?

Answer: Yes, there will be physical spot counselling if any vacant seats are available after all the regular rounds of seat allocation.

28. If I am not able to produce valid category certificate during online document verification, what will be consequence of it?

Answer: If you are not able to produce valid category certificate during online document verification, you will be considered as General Category Candidate.

29. If I am not able to produce valid sub-category certificate during online document verification, what will be consequence of it?

Answer: If you are not able to produce valid sub-category certificate during online document verification, you will not get the benefit of sub-category and will be considered to seat allotment in general open and corresponding open category if you belong to any category.

30. I have passed my diploma from state other than Uttar Pradesh and I do not have Parent domicile certificate of Uttar Pradesh. What will the consequence of it?

Answer: You are not eligible to participate in counselling as per eligibility criteria of B.Tech. Second Year (Lateral Entry).

31. What is the procedure to pay seat acceptance fee and remaining university fee?

Answer: You are required to pay seat acceptance fee online through the counselling portal available at link-<https://mmmut.admissions.nic.in/>

32. I do not want to participate in counselling after paying counselling fee. Can I get a refund of it?

Answer: No, Counselling Registration is non-refundable.

33. I have uploaded the documents but forgot to fill the choices. Am I eligible for counselling?

Answer: No, you are not eligible for counselling.
