Eligible Candidates for CSAB-2024 Special Round for NIT+ System

Candidates meeting the eligibility criteria as per JoSAA-2024 Business Rules can participate in the CSAB - 2024 Special Round Counselling for NIT+ System.

Candidates are categorized into the following types, based on their participation in JoSAA Rounds as well as the fresh candidates for CSAB special round counselling.

- **Type-1:** Candidates who did not register in JoSAA 2024 rounds but are eligible as per the eligibility criteria.
- **Type-2:** Candidates who have participated in JoSAA 2024 but have not been allotted any seat.
- **Type-3:** Candidates who have participated in JoSAA 2024 and have been allotted seats but cancelled due to non-payment of SAF.
- **Type-4:** Candidates who have exercised the EXIT option during JoSAA 2024.
- **Type-5:** Candidates who have participated in JoSAA 2024 and have been allotted seats in any IIT and later
 - a. their seats have been CANCELLED after document verification, OR
 - b. they have WITHDRAWN from their allotted seats, OR
 - c. they have taken admission therein.
- **Type-6:** Candidates who have participated in JoSAA 2024 and have been allotted seats in NIT+ System and have already SECURED ADMISSION at the allotted institute by paying the SAF and PAF.
- **Type-7:** Candidates who have participated in JoSAA 2024 and have been allotted seats in NIT+ system and later they have WITHDRAWN from their allotted seats.
- **Type-8:** Candidates who have participated in JoSAA 2024 and have been allotted seats in NIT+ System but later their seats have been CANCELLED after document verification and have not been allotted any seat in any of the subsequent JoSAA rounds (with their updated credentials provided they fulfill the eligibility).
- **Type-9:** Candidates who have participated in JoSAA 2024 and have been allotted seats in NIT+ System and have paid SAF and successfully completed document verification but their seats have been CANCELLED due to non-payment of PAF.

Fee Types:

SAF : Seat Acceptance Fee (in JoSAA Rounds)

PAF : Partial Admission Fee (at the end of JoSAA Rounds)

SRPF: Special Round Processing Fee

IAF-I : Institute Admission Fee-I

SREF : Special Round Enrolment Fee (SRPF + IAF-I) (to be paid at the time of Registration for CSAB Special Rounds)

IAF-II: Institute Admission Fee-II (to be paid for seat confirmation during CSAB Special Rounds)

The fee amount that needs to be paid by each type of candidate during the registration for CSAB Special Round is illustrated in the table below:

Notes: In addition to the above fees, following two adjustments may be applicable in certain cases:

Candidates whose categories were changed as per the following table during online document verification in JoSAA Rounds and have not paid Partial Admission Fee (PAF), are required to pay an additional amount of Rs. 17,500/-, of SAF which is the fee difference between GEN/GEN-EWS/OBC-NCL category and SC/ST/PwD category candidates.

IAF-II of 35,000/- (for GEN/GEN-EWS/OBC-NCL) and 12,500/- (for SC/ST/PwD) towards second installment of admission fee in the allotted institute have to be paid by all candidates, who have been allocated a seat in the CSAB Special Rounds. However, those candidates who have already paid PAF during JoSAA Rounds (i.e. Type-6 candidates) will not be required to pay IAF-II in CSAB Special Rounds.
