Attention to candidates registered in CSAB Special Round

If you are allotted a Seat in the CSAB Special Round – I, you must complete the following steps carefully

1. Exercise your willingness (FLOAT/ SLIDE/ FREEZE/ SURRENDER/ WITHDRAWAL). **If you do not opt for FLOAT/ SLIDE/ FREEZE, your currently allotted seat will get cancelled, including the seat allotted in the JoSAA Rounds (even if you had paid the PAF).**
2. Should you prefer to REJECT the allotted seat and wish to participate in Special Round-II, you may choose willingness as SURRENDER. In such a case, the seat allotted in JoSAA-2024 or CSAB-2024 Special Round-I will be cancelled. Allotment in Special Round-II will be considered from the choices higher than the surrendered seat.
3. Should you prefer to REJECT the allotted seat and DO NOT wish to participate in Special Round-II, you may choose willingness as WITHDRAW. In such a case, the seat allotted in JoSAA-2024 or CSAB-2024 Special Round-I will be cancelled, and no new allotment will be made in Special Round-II.
4. If a seat is allotted in Round-I and if the candidate exercises the willingness option FLOAT/ SLIDE/ FREEZE and has uploaded all the required documents, he/she **MUST pay the applicable IAF-II fee to confirm the seat.** Failure to pay the Institute Admission Fee-II (if applicable) by the deadline will AUTOMATICALLY lead to cancellation of the provisionally allocated seat and the candidate will not be considered for the seat allocation in the Special Round-II.
5. **Fresh candidates** (who did not register for JoSAA Rounds) **must upload their documents for ONLINE verification and respond to queries within the stipulated time** (Mon, 05 Aug 2024, 16:30 Hrs To Wed, 07 Aug 2024, 17:00 Hrs).
6. **PwD candidates must choose the reporting center for verification of PwD status within the stipulated time** (Mon, 05 Aug 2024, 16:30 Hrs to Wed, 07 Aug 2024, 17:00 Hrs).

However, if the PwD verification in JoSAA rounds is already done, such candidates need not reverify their PwD status except those who opted and got the higher choice seats in institutes having Special Eligibility Restrictions.
