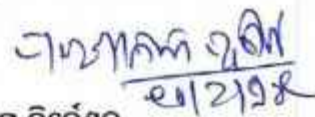

Respected Sir,

With due respect we Sridhar Behera, son of Kritan Behera, Bibuti Bushan Behera son of Biranchi Behera, Bata Krushna Behera, Son of Joginath Behera At/Po- Sagar PS-Kanpur, Dist-Cuttack beg to the few following lines for your kind information and necessary action.

It is respectfully mentioned herein that the above named persons i.e. Minaketan Behera son of Karunakar Behera, At/Po-Sagar, PS-Narsingpur, Dist-Cuttack has been continuing as Postal Assistant in the Postal Department South Division, Cuttack by submitting false caste certificate 'Koli' instead of 'Vani' before the authority, though as per the Khata No.666, Kisama-gharabadi and in the said ROR the caste has been mentioned as 'Vani' which is belongs to SEBC/OBC Category but by manipulating the same obtained a caste certificate of 'Koli' which belongs to SC Community from the authority i.e. Tahasildar, Narsingpur in Misc Case No.337 of 2001 showing that he belongs to caste of 'Koli' instead of 'Vani' which is clear false, fabricated, suppression of fact and violative of the Government Servant Conduct Rules.

So far as one Sarojini behera, D/O Sauri Behera, At/Po-Sagar, PS-Narsingpur, Dist-Cuttack also by obtaining false certificate in Misc Case No.36 of 2001 issued by the Tahasildar, Narsingpur, Dist-Cuttack showing as Sub-caste of 'Koli' instead of 'Vani' though as per the Gharabadi Pata No.582, in the pata though the caste has been mentioned in 'Vani', but she has obtained false caste certificate before the Postal Authority now continuing as Postal Assistant in South Division, Cuttack which is clear violation of Government

Service Conduct Rule, Suppression of fact, forgery, cheating the authority. The Vina Community comes under the SEBC / OBC Category where as the 'Koli' community comes under the community comes under the SC Community as per ORV Act.

One Sarat Chandra Behera son of Sankarsan Behera At/Po-Sagar, PS-Narsingpur, Dist-Cuttack also by submitting false certificate 'Koli' instead of 'Vani' before the D.I.G.P GC CRPF Khatkhati, Assam now continuing as Sepahi before the said authority. Though he has submitted that in Misc case No.427/2006 the Cast Certificate issued by the tahasildar Narsingpur in his favour is totally false on the ground that the misc case No.427/2006 has been filed by one Prabhasini Sethi D/O Upendra Kumar Sethi of village Nuagaon Caste-Dhoba, but not filed by Sarat Chandra Behera the document which has been obtained by R.T.I Act, on which Misc Case the Sarat Chandra Behera has submitted and obtaining the caste certificate 'Koli' i.e. SC Community instead of 'Vani' i.e. OBC / SEBC Community is totally False and such Mis Case has neither has been filled by the Sarat Chandra Behera nor certificate has been issued by the Tahasildar, Narsingpur but in same Misc Case No.427 of 2006 has been issued in favour of Prabhasini Sethi not in favour of Sarat Chandra Behera. So, by giving the false certificate now discharging duty as Sepoy before the DIG GC CRPF Khatkhati, Assam is totally false, fabricated and forgery and violative of Government Servant Conduct Rules. //

One Kalpabasi Behera son of Rabindra Behera At/Po-Sagar, PS-Narsingpur, Dist-Cuttack by giving false caste certificate 'Koli' instead of 'Vani' in Misc Case No.975 of 2006 which has neither issued nor any Misc Case filled before the Tahasildar, Narsingpur for obtaining the caste certificate on the ground that the RTI document which has been issued by the Tahasildar, Narsingpur in letter no.3377 dated 11.12.2007 categorically stated in the said R.T.I document in 2006 the last Misc Case No.973/2006 applied by one Lalit Mohan Nayak of village- Ranibuhni the total no. of certificate issued in 2006 is 119 but though the Kalpabasi Behera has submitted the caste certificate in Misc //

Case No.973 of 2006 for admission of B.ED in 2017-2019 in Roll No.48 office of Naba Krushna Chowdary C.T.E, Angul is totally false, fabricated, Manipulation, forgery.

So far as in case Hemanta Kumar Behera son of Sankarasan behera village-Sagar, PS-Narsingpur, Dist-Cuttack, now continuing as Data Entry Operator in the Office of Banki Central Co-operative Bank, Banki in Sagar Branch in the District of Cuttack by giving false certificate 'Koli' instead of 'Vani' in Misc Case No.642 of 2007 is totally false on the ground that as per the RTI document issued by the Tahasildar in letter No.3377 dated 11.12.2007 no such Misc case has been filed the last Misc Case No. is 636 of 2007 filled by Iswar Guru of village -Panochama and in Khata No.666 the caste certificate categorically mention as 'Vani' instead of 'Koli' but by giving false, fabricated and by manipulating the document, obtained false caste certificate by submitting the said before the authority now discharging duty as Data Entry Operator is totally false, fabricated. Further in case of Sasmita Behera, D/O Mangul Behera, P.S-Narsingpur, Dist-Cuttack by giving false caste certificate 'Koli' instead of 'Vani' now continuing as Sweeper in the Office of Acharya Harihar Regional Center, Cuttack S.C.B Medical College & Hospital, Cuttack and Misc. Case No.439 of 2006 such type of Misc Case has not been filled before the Tahasildar, Narsingpur in the year 2006, the document which has been obtained by R.T.I Act, the said Misc Case neither filled nor issued caste certificate in favour of the above named so, the caste certificate submitted by Sasmita Behera is totally false and Manipulated.

One Rasmilata Behera. D/O. Baribundhu Behera At/Po-Sagar, PS-Narsingpur, Dist-Cuttack now continuing as Cooker TRW School, Narsingpur Block under the BEO, Narsingpur by submitting the caste certificate 'Koli' instead of 'Vani' in Misc Case No.965 of 2006 and in Khata No.582 categorically mentioned that caste is 'Vani' instead of 'Koli' and by the Misc Case No.965 of 2006 in which the caste certificate issued in the Favour of above cited name has not been issued by the Tahasildar on the ground that the

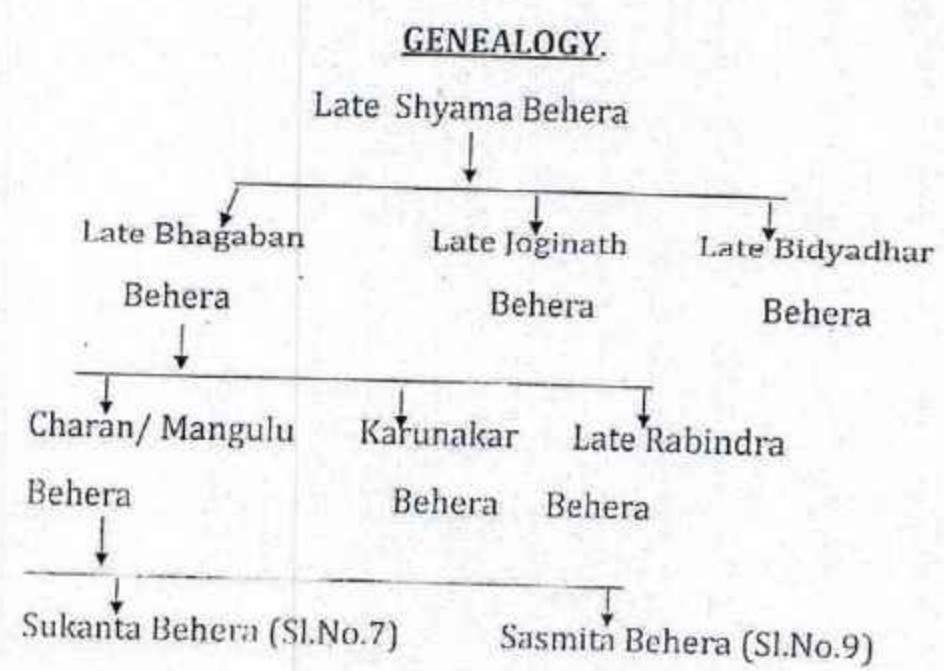

1. Sukanta @ Sukanti Behera, Son of Mangulu @ Charan Behera, At/PO: Sagar, Dist: Cuttack (Sl.No. 7).

So far as the allegation made against Sukanta @ Sukanti Behera, Son of Mangalu @ Charan Behera, (Sl.No. 7) is concerned that the genealogy of Sukanta Behera is given below:

2. It is pertinent to mention here that so far as allegation application the Misc No. 1709 of 2001, which has been against Sukant @ Sukanti Behera S/o Charan Behera is concerned that the said document has been obtained by the complainant under RTI Act vide letter No. 5188 dated 31.12.2021. In the said RTI document in Annexure-1 S.No.6 categorically reflected that in Misc. No. 1709 of 2001 has been issued in favour of Sukanta Behera, Son of Charan Behera and his caste has been reflected as "Koli" instead of "Vina" (for kind perusal annexed the RTI document herewith) and also further mentioned that the RTI documents which has been obtained by the complainant vide letter No.2359 dated 05.07.2019, in the said RTI document they have categorically mentioned in Misc. No. 1709 of 2001 the caste certificate have been issued I favour of Charan Behera but not in favour of Ssukant Behera but in the Misc. Case No. 1709 of 2001 the caste certificate issued illegally by manipulating in favour of Sukant Behera and I the said Register the name and village have only mentioned but not the caste. (A Xerox copy of the said RTI document is marked herewith for kind perusal of the court).

3. That It is further mentioned that the caste of Sukanta Behera Son of Charan Behera has categorically mentioned the caste is "VINA" in Khata No. 354, 353, 595 and 666 but the Tahasildar Narasinghpur issued the caste certificate "KOLI" in favour of the complainant bearing Misc. Case No. 1709 of 2001 whereas in the ROR the caste has been mentioned as "VINA". So far as the Khata No. 354 and 595 is concern that is the ancestral property of the complainant and in the said ROR the caste has been categorically mentioned as "VINA".

Xerox copy of the caste certificate of Sukanta Behera and RTI document dated 31.12.2021 and RTI letter dated 05.07.2021 are marked here with for kind perusal.

4. It is pertinent to mentioned here that the certificate which has been issued baring Misc. Case No. 1709 of 2001 but that has been wrongly mentioned in the complain petition as Misc. case No. 974 of 2016 instead of 1709 of 2001 but 974 of 2006 has been issued in favour of Tirthabasi Behera Son of Rabindranath Behera. The Misc. case No. 1709 of 2001 issued in favour of Sukanta Behera Son of Charan Behera but the RTI document which has been issued by the Tahasildar vide letter No. 5188 dated 31.12.2021 mentioned therein that 1709 by 2001 has been issued in favour of Charan Behera, Son of Joginath Behera. But Mangulu Behera and Charan Behea are one person. Mangulu Behera is the son of Bhagaban Behera but nephew of Joginath.

Behera and son and daughter of Mangulu Behera that is Sukant Behera and Sasmita Behera by manipulate their father's name Mangulu Behera and Charan Behera. They obtain the caste certificate in their favour by following backdoor policy.

(Xerox copy of the caste certificate of Sukant Behera and RTUI document dated 31.12.2021 and RTI are letter dated 05.07.2021 marked here with for kind perusal.

But it is further mentioned that the father of Sasmita Behera and Sukanta Behera is Mangulu Behera but when Sasmita Behera applied for issuance of caste certificate they mentioned her father's name as Mangulu Behera but when the brother of Sasmita Behera namely Sukanta Behera has applied for issuance of caste certificate before the authority they mentioned the father's name as Charan Behera but Mangulu and Charan Behera are one but by manipulating her father's name they obtained the caste certificate.

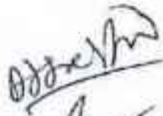
