Sub:- Regarding submission of fake / false caste certificate of Minaketan Behera, Sarojini Behera, Tribasi Behera, Sarat Chandra Behera, Kalpabasi Behera, Hemanta Behera, Sasmita Behera, Sukanti Behera, Rasmilata Behera of village Sagar, Narsingpur, Dist-Cuttack.

Respected Sir,

With due respect we Sridhar Behera, son of Kritan Behera, Bibuti Bushan Behera son of Biranchi Behera, Bata Krushna Behera, Son of Joginath Behera At/Po- Sagar PS-Kanpur, Dist-Cuttack beg to the few following lines for your kind information and necessary action.

It is respectfully mentioned herein that the above named persons i.e. Minaketan Behera son of Karunakar Behera, At/Po-Sagar, PS-Narsingpur, Dist-Cuttack has been continuing as Postal Assistant in the Postal Department South Division, Cuttack by submitting false caste certificate 'Koli' instead of 'Vani' before the authority, though as per the Khata No.666, Kisama-gharabadi and in the said ROR the caste has been mentioned as 'Vani' which is belongs to SEBC/OBC Category but by manipulating the same obtained a caste certificate of 'Koli' which belongs to SC Community from the authority i.e. Tahasildar, Narsingpur in Misc Case No.337 of 2001 showing that he belongs to caste of 'Koli' instead of 'Vani' which is clear false, fabricated, suppression of fact and violative of the Government Servant Conduct Rules.

So far as one Sarojini behera, D/O Sauri Behera, At/Po-Sagar, PS-Narsingpur, Dist-Cuttack also by obtaining false certificate in Misc Case No.36 of 2001 issued by the Tahasildar, Narsingpur, Dist-Cuttack showing as Sub-caste of 'Koli' instead of 'Vani' though as per the Gharabadi Pata No.582, in the pata though the caste has been mentioned in 'Vani', but she has obtained false caste certificate before the Postal Authority now continuing as Postal Assistant in south Division, Cuttack which is clear violation of Government

Service Conduct Rule, Suppression of fact, forgery, cheating the authority. The Vina Community comes under the SEBC / OBC Category where as the 'Koli' community comes under the community comes under the SC Community as per ORV Act.

One Sarat Chandra Behera son of Sankarsan Behera At/Po-Sagar, PS-Narsingpur, Dist-Cuttack also by submitting false certificate 'Koli' instead of 'Vani' before the D.I.G.P GC CRPF Khatkhati, Assam now continuing as Sepahi before the said authority. Though he has submitted that in Misc case No.427/2006 the Cast Certificate issued by the tahasildar Narsingpur in his favour is totally false on the ground that the misc case No.427/2006 has been filed by one Prabhasini Sethi D/O Upendra Kumar Sethi of village Nuagaon Caste-Dhoba, but not filed by Sarat Chandra Behera the document which has been obtained by R.T.I Act, on which Misc Case the Sarat Chandra Behera has submitted and obtaining the caste certificate 'Koli' i.e. SC Community instead of 'Vani' i.e. OBC / SEBC Community is totally False and such Mis Case has neither has been filled by the Sarat Chandra Behera nor certificate has been issued by the Tahasildar, Narsingpur but in same Misc Case No.427 of 2006 has been issued in favour of Prabhasini Sethi not in favour of Sarat Chandra Behera. So, by giving the false certificate now discharging duty as Sepoy before the DIG GC CRPF Khatkhati, Assam is totally false, fabricated and forgery and violative of Government Servant Conduct Rules.

One Kalpabasi Behera son of Rabindra Behera At/Po-Sagar, PS-Narsingpur, Dist-Cuttack by giving false caste certificate 'Koli' instead of 'Vani' in Misc Case No.975 of 2006 which has neither issued nor any Misc Case filled before the Tahasildar, Narsingpur for obtaining the caste certificate on the ground that the RTI document which has been issued by the Tahasildar, Narsingpur in letter no.3377 dated 11.12.2007 categorically stated in the said R.T.I document in 2006 the last Misc Case No.973/2006 applied by one Lalit Mohan Nayak of village- Ranibuhni the total no. of certificate issued in 2006 is 119 but though the Kalpabasi Behera has submitted the caste certificate in Misc

Case No.973 of 2006 for admission of B.ED in 2017-2019 in Roll No.48 office of Naba Krushna Chowdary C.T.E, Angul is totally false, fabricated, Manipulation, forgery.

So far as in case Hemanta Kumar Behera son of Sankarasan behera village-Sagar, PS-Narsingpur, Dist-Cuttack, now continuing as Data Entry Operator in the Office of Banki Central Co-operative Bank, Banki in Sagar Branch in the District of Cuttack by giving false certificate 'Koli' instead of 'Vani' in Misc Case No.642 of 2007 is totally false on the ground that as per the RTI document issued by the Tahasildar in letter No.3377 dated 11.12.2007 no such Misc case has been filed the last Misc Case No. is 636 of 2007 filled by Iswar Guru of village -Panochama and in Khata No.666 the caste certificate categorically mention as 'Vani' instead of 'Koli' but by giving false, fabricated and by manipulating the document, obtained false caste certificate by submitting the said before the authority now discharging duty as Data Entry Operator is totally false, fabricated. Further in case of Sasmita Behera, D/O Mangul Behera, P.S-Narsingpur, Dist-Cuttack by giving false caste certificate 'Koli' instead of 'Vani' now continuing as Sweeper in the Office of Acharya Harihar Regional Center, Cuttack S.C.B Medical College & Hospital, Cuttack and Misc. Case No.439 of 2006 such type of Misc Case has not been filled before the Tahasildar, Narsingpur in the year 2006, the document which has been obtained by R.T.I Act, the said Misc Case neither filled nor issued caste certificate in favour of the above named so, the caste certificate submitted by Sasmita Behera is totally false and Manipulated.

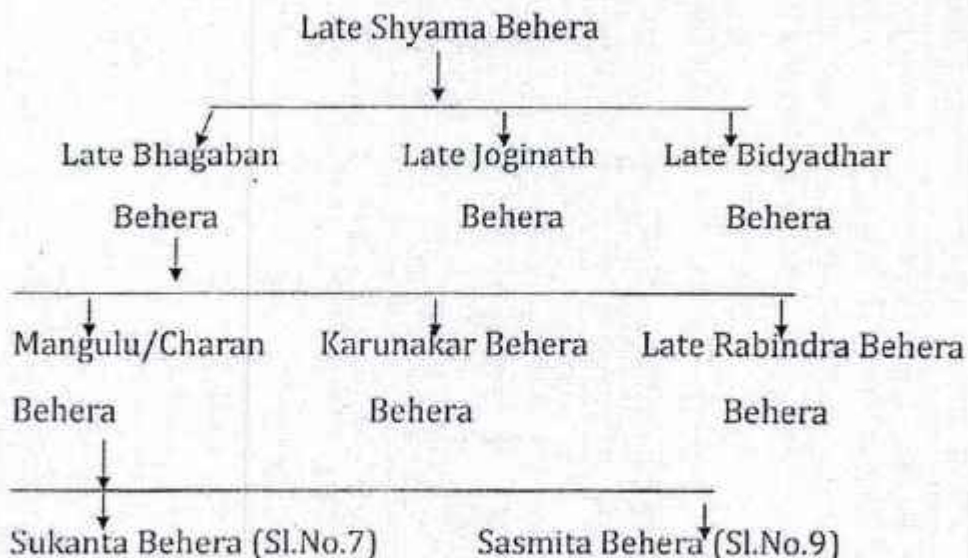

So far as the allegation made against Sasmita Behera, Daughter of Mangalu Behera, (Sl.No. 9) is concerned that the genealogy of Sasmita Kumar Behera is given below:

(All are by caste Vina as per ROR 354, 353, 595 & 666)

2. It is pertinent to mentioned here that so far as allegation against Sasmita Behera is concerned that the Misc No. 439 of 2006 which has been made against Sasmita Behera D/o Mangulu Behera is concerned that the said document has been obtained by the complainant under RTI Act vide letter No. 5188 dated 31.12.2021. In the said RTI document in Annexure-1 Sl.No.6 categorically reflected that in Misc. Case No. 439 of 2006 has been issued in favour of Sasmita Behera, Daughter of Mangulu Behera and his caste has been reflected as "Koli" instead of "Vina" (for kind perusal annexed the RTI document herewith) and also further mentioned that the RTI documents which has been obtained by the complainant vide letter No.2359 dated 05.07.2019, in the said RTI document they have categorically mentioned that the Misc. Case No. 439 of 2006 regarding issuance of caste certificate is not available in this office and those Xerox copy of the register they have given under RTI in the said document in Misc. Case No. 439 of 2006 only the name & village has been mentioned but no caste has been mentioned. (A Xerox copy of the said RTI document is marked herewith for kind perusal of the court).

3. That It is further mentioned that the caste of Sasmita Behera Daughter of Mangulu Behera has categorically mentioned the caste is "VINA" in Khata No. 354, 353, 595 and 666 but the Tahasildar Narasinghpur issued the caste certificate

"KOLI" in favour of the complainant bearing Misc. Case No. 439 of 2006 whereas in the ROR the caste has been mentioned as "VINA". The Khata No. 354 and 595 are the ancestral property of the complainant and in the said ROR the caste has been categorically mentioned as "VINA".

Xerox copy of the ROR No. 354, 353, 595 and 666 are annexed herewith for kind perusal of the court and ascertain the caste of the complainant).

4. It is mentioned before you that the RTI document obtained by the complainant bearing letter 3377 of 2007 and 2574 of 2012 categorically mentioned and such type of applicants name the caste certificate have never been issued in the year 2006. But when the complainant obtained the RTI document in the year 2019 for the year 2006. In the said document the name of Sasmita Behera has been reflected in Misc. No. 439 of 2006. It is mentioned before you that in which RTI document is correct whether the RTI document 2007 & 2012 or 2019 is correct and which is genuine.

But it is further mentioned that the father of Sasmita Behera and Sukanta Behera is Mangulu Behera but when Sasmita Behera applied for issuance of caste certificate they mentioned her father's name is Mangulu Behera but when the brother of Sasmita Behera namely Sukanta Behera has applied for issuance of caste certificate before the authority they

mentioned the father's name as "Charan Behera" but Mangulu and Charan Behera are one but by manipulating her father's name they obtained the caste certificate. .



Preliminary Show Cause reply Filed by the Respondent

I, Sasmita Behera aged about 32 years, D/o- Mangulu Behera, A.T/P.O.- Sagar, P.S.- Narasinghpur, Dist- Cuttack, Solemnly affirm and state as follows:

- 1) That the allegations as has been raised by the complainants against me with regard to my caste is totally false, fabricated and concocted one.
- 2) That the complainants has filed the complain enclosing such documents which are contradictory. The complainants submitted the Letter No.3377/ dated 11.12.2007, but the respondent applied the same

under RTI Act before the Tahasildar, Narasinghpur vide RTI NO. 40/2025. The PIO Narasinghpur vide Letter No. 2427/ dated 09.05.2025 intimated that no such application available in this office. Further complainants have submitted the list of certificate issued for S.T. persons vide letter no. 2574/ dated 26.05.2012 since year 2003 to 2011 wherein it is stated that in year 2006 only six six persons have been issued S.T.Certificate but in the year 2011 no ST certificate issued in but when one Tirhabasi Behera applied under the RTI Act vide Letter No.2979/ 13.07.2022 applied for before the Tahasildar, Narasinghpur who supplied the information that in year 2006 Fourteen persons have been issued S.T.Certificate and year 2011 six persons have been issued S.T.Certificate which is required to be examined. Year 2007 complainant have informed only 9 certificate has been issued but PIO < N. S.Pur supplied information to Tirthabasi Behera that 11 persons have been issued S.T.Certificate . Hence it is very much clear that the complainants

giving wrong information trying to mislead this Hon'ble Scrutiny Committee.

- 3) That complainants have submitted a document vide letter no. 2358/dated 05.07.2019 wherein they stated that the DA intimated to PIO that his predecessor has not handed over the case record since the year January 2006 to December 2006, but how the complainants filed the certificates without any authorities signature and from which source they got it should have examine. Further the list are supplied by PIO is also mismatched i.e. the certificate issued to complainant Sridhar Behera vide 1884/1995 by the Tahasildar, Narasinghpur, in such number has been issued in the name of Kirtan Behera.
- 4) That in a relevant document as submitted by the complainant that during inquiry Kalpabasi Behera and Karunakar Behera deposed that there belongs to Vina caste but both Kalpabasi Behera and Karunakar Behera have filed an individual affidavit stating that the Tahasildar taken signature in a blank paper vide Affidavit No.1617 dated 31.03.2023.

5) while I was being a minor and was reading in the school I have been sanctioned pre-matric scholarship which is meant for only Scheduled Tribe/Caste student. Identifying me as Scheduled Tribe. I have also applied for a certificate in this regard but this same has not yet been received.

6) That it is further relevant to mention here that when I was attaining only 12 years for submission of the caste certificate before my school, I applied my caste certificate before the Tahasildar, Narasinghpur through my father guardian. The Tahasildar, Narasinghpur after following due procedure of law and under the inquiry issued my caste certificate vide M.C. Caste Certificate No.439/2006.

7) That after completion my education and due to below poverty my father being a poor and labour class category I could not prosecute my higher study and awaited for a job.

8) That in the meantime the State Government came up an advertisement to fill up a sweeper post against vacancy . I being a poor person applied for the said post and after selection I have been issued the appointment letter dated 24.02.2014 and since then I am performing my duties with satisfaction of my higher authorities.

9) That when I was continuing in my post as a sweeper suddenly a show cause notice was issued to me by the administrative officer regarding submission of false caste certificate and stopped my salary. Finding no other alternative remedy I filed a civil suit bearing number C.S No.46/2019 before the Additional Civil Judge (Junior Division) Narasinghpur for declaration to her as member of ST community and other relief. During pendency of the suit and also stop the salary the respondent filed a W.P bearing W.P.(C) No 37186/2020 with a prayer to direct the Opp Party No.2 & 3(Director and Administrative officer Of Acharya Harihar Regional Cancer Center,)Cuttack for disbursement of

salary and other prayers impleading the Collector, Cuttack and the Tahasildar, Narasinghpur as a defendants.

10) That on 27.01.2021 the Hon'ble High court after hearing the parties disposed of the writ petition holding that the issue involving the writ petition become academic and advised her may revive her claim dependent on the civil court decree ultimately

11) That the learned civil court on 05.11.2021 passed the judgment/order that the suit of plaintiff is partially maintainable and allowed and the same stand decreed accordingly on contest against the defendants. Further ordered that the documents exhibited by the present respondent are on rebutted are presumed to be genuine and correct. The said judgment is still existing without any challenge in any higher forum.

12) That in pursuance to the order dated 27.01.2021 of the Hon'ble High court present respondent made an application to her authorities enclosing the judgment and decree of learned Additional Civil Judge (Junior Division) Narasinghpur with a prayer to disburse the salary. But

due to non disposal of her application she again approach the Hon'ble High court writ petition bearing W.P(C)No. 26017/2022 on 14.08.2023 disposed of the writ petition with a direction to disposed the representation of the petitioner within a period of 3 month. Though the authority allowed the present respondent to draw her contractual salary and for draw of arrears contractual salary and accordingly the present respondent drawing her salary till date.

13) That though there was allegation raise against her with regard to her caste and said dispute has already been adjudicated by the competent court of law. Now again the complainants raised same allegation with regard to her Caste which is not at all correct but also completely violate the principle of natural justice.

In view of the above facts and circumstances the present respondent applied certified copy of order of the Hon'ble High Court, Civil Court judgments and revenue records but the same has not yet been received by her for which it is very much necessary the relevant
