**Preliminary Show Cause reply Filed by the Respondent**

I, Tirthabasi Behera aged about 31 years, S/o- Late Rabindra Nath Behera, A.T/P.O.- Sagar, P.S.- Narasinghpur, Dist- Cuttack, Solemnly affirm and state as follows:

- 1) That the allegations as has been raised by the complainants against me with regard to my caste is totally false, fabricated and concocted one.
- 2) That the complainants has filed the complain enclosing such documents which are contradictory. The complainants submitted the Letter No.3377/ dated 11.12.2007, but the respondent applied the same under RTI Act before the Tahasildar, Narasinghpur vide RTI NO. 40/2025. The PIO Narasinghpurvide Letter No. 2427/ dated 09.05.2025

intimated that no such application available in this office. Further complainants have submitted the list of certificate issued for S.T. persons vide letter no. 2574/ dated 26.05.2012 since year 2003 to 2011 wherein it is stated that in year 2006 only six six persons have been issued S.T.Certificate but in the year 2011 no ST certificate issued in but when one Tirhabasi Behera applied under the RTI Act vide Letter No.2979/ 13.07.2022 applied for before the Tahasildar, Narasinghpur who supplied the information that in year 2006 Fourteen persons have been issued S.T.Certificate and year 2011 six persons have been issued S.T.Certificate which is required to be examined. Year 2007 complainant have informed only 9 certificate has been issued but PIO Narasinghpur supplied information to Tirthabasi Behera that 11 persons have been issued S.T.Certificate . Hence it is very much clear that the complainants giving wrong information trying to mislead this Hon'ble Scrutiny Committee.

3) That complainants have submitted a document vide letter no. 2358/dated 05.07.2019 wherein they stated that the DA intimated to PIO that his predecessor has not handed over the case record since the year

January 2006 to December 2006, but how the complainants filed the certificates without any authorities signature and from which source they got it should have examine. Further the list are supplied by PIO is also mismatched i.e. the certificate issued to complainant Sridhar Behera vide 1884/1995 by the Tahasildar, Narasinghpur, in such number has been issued in the name of Kirtan Behera.

4) That in a relevant document as submitted by the complainant that during inquiry Kalpabasi Behera and Karunakar Behera deposed that there belongs to Vina caste but both Kalpabasi Behera and Karunakar Behera have filed an individual affidavit stating that the Tahasildar taken signature in a blank paper vide Affidavit No.1617 dated 31.03.2023.

5) While I was being a minor and was reading in the school I have been sanctioned pre-matric scholarship which is meant for only Scheduled Tribe/Caste student. Identifying me as Scheduled Tribe. I have also applied for a certificate in this regard but this same has not yet been received. Further it is submitted that the documemnts as has been submitted by the complainants are not legible for which he could not

able to file his final reply unless this Hon'ble Court will supply the legible copy of such documents.

6) That it is further relevant to mention here that when I was attaining only 12 years for submission of the caste certificate before my school, I applied my caste certificate before the Tahasildar, Narasinghpur through my father guardian. The Tahasildar, Narasinghpur after following due procedure of law and under the inquiry issued my caste certificate vide M.C. Caste Certificate No.974/2006.

7) That after completion my education and due to below poverty my father being a poor and labour class category I could not prosecute my higher study and awaited for a job.

8) That in order to established my case I applied some relevant documents vide C.A No. 198/25 & 199/25 before the Tahasildar, Narasinghpur but the same is still pending.

9) That when allegation raised against my caste certificate. Finding no other alternative remedy I filed a civil suit bearing number C.S

R. R. R.

No.24/2019 before the Additional Civil Judge (Junior Division) Narasinghpur for declaration to his as member of ST community and other relief. Impleading the Collector, Cuttack and the Tahasildar, Narasinghpur as a defendants.

10) That the learned civil court on 21.07.2022 passed the judgment/order that the defendant No.1 has rightly prepared the ROR, vide Khata No.928/244 of Mouza Sagar under Tahasil Narasinghpur in favour of the son of the plaintiff as per the documents given and exhibited since they are un rebuttable, genuine and correct as well as the Misc. Certificate Case No.974/2006 is considered to be genuine without questioning its contents and proof of the same. The said judgment is still existing without any challenge in any higher forum.

11) That though there was allegation raise against her with regard to his caste and said dispute has already been adjudicated by the competent court of law. Now again the complainants raised same allegation with regard to his Caste which is not at all correct but also completely violate the principle of natural justice.

In view of the above facts and circumstances the present respondent applied certified copy of order of the Civil Court judgments and revenue records but the same has not yet been received by her for which it is very much necessary the relevant documents to substantiate her case. The facts stated above are true to the best of my knowledge and believe as based on record.

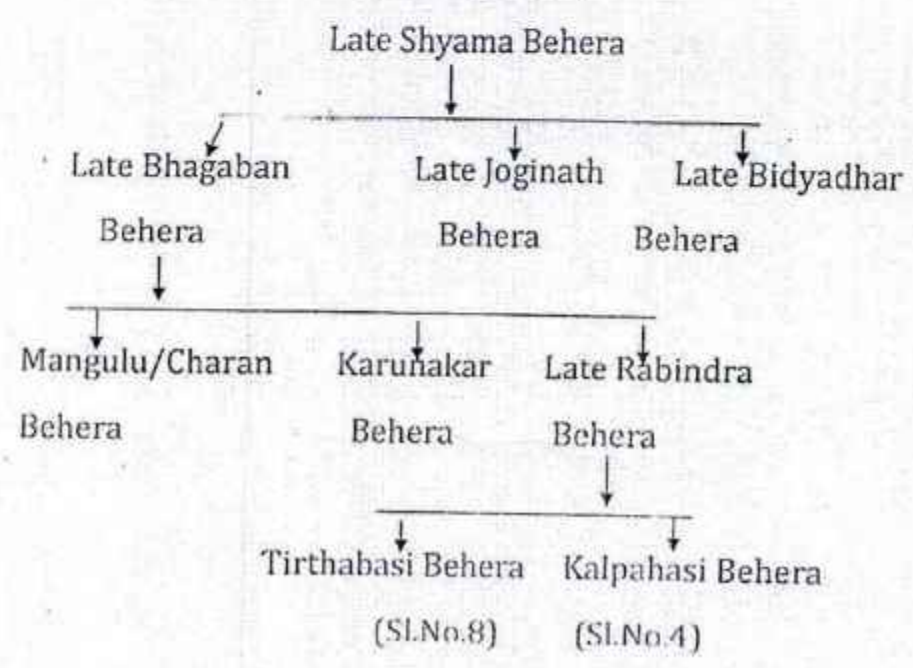

As per the direction by the court dated 19.09.2024 the complainant filed detailed report with photo copy and genealogy separately each person on which against the allegation has been made.

1. Tirthabasi Behera, Son of Rabindranath Behera, At/PO: Sagar, Dist: Cuttack (Sl.No. 8).

So far as the allegation made against Tirthabasi Behera, Son of Rabindranath Behera, (Sl.No.8) is concerned that the genealogy of Tirthabasi Behera is given below:

2. It is mentioned here that in the allegation application the Misc. No. 974 of 2006 which has been made against Tirthabasi Behera is concerned that the Misc. No. 974 of 2006 regarding issuance of caste certificate in favour of Tirthabasi Behera has never been issued in the year 2006 on the ground that the RTI document issued by the Tahasildar, Narasinghur in letter No. 3377 dated 11.12.2007, in the said information document they have categorically mentioned that in the year 2006 the total number of ST certificate have been issued from Sl.No.74 to Sl.No.119 (i.e. total number 46) and the last Misc. number is 973. In the said year out of 46 ST certificates only 9 (nine) number of "KOLI" caste certificate have been issued and also in RTI letter No. 2574 dated 26.05.2012 the Tahasildar, Narasinghpur categorically mentioned that in the year 2006, 9 numbers of "KOLI" caste certificate have been issued. But it is surprisingly mentioned before you that the RTI document which have been obtained by the complainant vide letter No. 2359 dated 05.07.2019, in the said RTI document (caste certificate issue register in the year 2006) categorically reflected therein that the Misc. number 974 and 975 has been added and the handwriting also vary because in the RTI document 2019 the handwriting have not been matched from misc. number 972, 974 & 975. In Misc. number 972, 2(two) ST certificate have been issued, one in favor of Basant Kumar Majhi and one in favour of Sabita Behera. How it is possible? It is categorically indicate the



certificate have been issued illegally and by following backdoor policy (Xerox copy of RTI document / letter number 3377 dated 11.12.2007, RTI letter No. 2574 dated 26.05.2012 and letter No. 2358 dated 05.07.2019 are annexed herewith for kind perusal of the court).

3. So far as the Misc. No. 974 of 2006 is concerned, the said document has been obtained by the complainant under RTI Act vide letter No. 5188 dated 31.12.2021, in the said RTI document in Annexure-1 serial No.8 categorically reflected that in Misc. No. 974 of 2006 has been issued in favour of Tirthabasi Behera, Son of Rabindranath Behera and his caste has been mentioned as "KOLI" instead of "VINA" (for kind perusal the said RTI document is annexed herewith). And also further mention that the RTI document which has been obtained by the complainant vide letter No. 2359 dated 05.07.2019 in the said RTI document they have categorically mentioned that the Misc. No. 974 of 2006 has not been available in this office and RTI document obtained vide letter No. 1452 dated 19.04.2024 is annexed herewith for kind perusal and the RTI Xerox copy of the caste certificate obtain under RTI act dated 11.03.2019.

4. That, the father of Minaketan Behera named as Karunakar Behera along with Kalpabasi Behera and Rabindranath Behera have given their statement before the Tahasildar, Narasinghpur along with RI, Sagar, ARI Sagar and ARI Champeswar on

04.01.2020. In the said self declaration statement by Kalpabasi, Karunakar and Rabindanath Behera before the Tahasildar, Narasinghpur stated therein that they are belongs to "VINA" caste and also further stated that their forefathers had been doing the work of Tulavina.

(Xerox copy of the self declaration statement dated 04.01.2020 is annexed herewith for kind perusal of the court).


