The minutes are as follows.

Important Observations/Directions of SLSMC
The proposed 263 BLC projects of 9804 DUs are recommended for the approval of the CSMC. • 3rd SLAC Meeting - 77 projects of 2835 DUs • 4th SLAC Meeting - 186 projects of 6969 DUs
The proposed 14 AHP projects of 4 th SLAC of 8292 DUs are recommended for the approval of the CSMC, subject to fulfillment of all the compliances.
The proposed 5 AHP-PPP of 3 rd SLAC projects of 3097 DUs are recommended for the approval of the CSMC, subject to fulfillment of all the compliances.
The Capacity Building Plan of PMAY(U) 2.0 is recommended for the approval of the SLSMC.
SLSMC has noted the challenges faced in Implementation of PMAY(U) 2.0 and has requested MoHUA to take necessary action regarding issues related to revision of income criteria and inclusion of additional villages in PMRDA and NMRDA regions.
SLSMC acknowledged the shortage of dedicated government office space and recommended that the PMU procure suitable private office premises in the vicinity of Mantralaya.

1. Income Criteria of EWS beneficiaries under PMAY(U) 2.0 is 3 lakhs. MoHUA is requested to revise the income criteria as follows:

2. Villages of RDAs are missing in Unified Web Portal (UWP) which hampers project sanctioning in the respective villages*:

- PMRDA region – 418 Villages
- NMRDA region – 691 villages

* As per Point 2.2 of Operational Guidelines of PMAY(U) 2.0 –

The Cities/Towns and areas falling under Notified Planning Areas, Notified Planning/ Development area under the jurisdiction of Industrial Development Authority/ Special Area Development Authority/Urban Development Authority or any such Authority, where PMAY-U is being implemented will continue to be covered under PMAY-U 2.0

3. Requirement for office space for State level Project Management Unit

- State level Project Management Unit (PMU) instituted under the Housing Department for implementation of PMAY(U). PMAY(U) 2.0 and Girni Kamgar Gharkul Yojana (as per GR no. PMAY-2023/C.R. 121/GND2 dated 14 August 2023 and GIKAGH-2023/C.R. 128/GND-2 dated 15 March 2024.)
- There is requirement of office space for 20 officials in or near Mantralaya, Mumbai. The PMU will have accounts, MIS, marketing and technical wings.
- Request was submitted to the Collector, Mumbai for allocation of vacant Government premises, however, the allocation has been pending for over 8 months.

SLSMC Appraisal:

- SLSMC noted the issues regarding revision of income criteria and inclusion of additional villages in PMRDA and NMRDA region and has requested MoHUA to take necessary action for their resolution.
- SLSMC acknowledged the shortage of dedicated government office space and recommended that the PMU procure suitable private office premises in the vicinity of Mantralaya.

The proposals as listed & enclosed in 3rd meeting of State Level Sanctioning and Monitoring Committee (SLSMC) of PMAY (U) dated 25th November 2025 recommended for approval of CSMC of PMAY (U) 2.0.

Important Observations/Directions of SLSMC

The proposed 263 BLC projects of 9804 DUs are recommended for the approval of the CSMC.

- 3rd SLAC Meeting - 77 projects of 2835 DUs
- 4th SLAC Meeting - 186 projects of 6969 DUs

The proposed 14 AHP projects of 4th SLAC of 8292 DUs are recommended for the approval of the CSMC, subject to fulfillment of all the compliances.

The proposed 5 AHP-PPP of 3rd SLAC projects of 3097 DUs are recommended for the approval of the CSMC, subject to fulfillment of all the compliances.
