

Minutes of the 4th meeting of State Level Sanctioning and Monitoring Committee (SLSMC) for PMAY(U) 2.0- HFA held on 2nd February 2026

The minutes are as follows.

Important Observations/Directions of SLSMC
The proposed 220 BLC projects of 11,319 DUs are recommended for the approval of the CSMC.
The proposed 8 AHP projects of 4203 PMAY EWS DUs and 29 AHP-PPP projects of 26,850 PMAY EWS Dus are recommended for the approval of the CSMC. The Committee noted that certain AHP and AHP-PPP projects exceed the ASR value; however, considering that the ASR in some areas is significantly lower than the prevailing market rates, the Committee approved such projects. The projects are approved subject to the following conditions: <ul style="list-style-type: none">a) Commencement of project construction shall be permitted only after achieving a minimum of 25% beneficiary attachment.b) Beneficiary attachment shall be completed within a maximum period of four (4) months from the date of issuance of the work order to the contractor/developer.c) The Government shall not bear any financial liability towards the developer/contractor for houses remaining unallotted or vacant upon completion of the project.
The proposed 1 ARH project of 8601 DUs is recommended for the approval of the CSMC provided that the project is executed following guidelines of PMAY(U) 2.0.
As was directed by the Hon. Chief Secretary and Chairman, SLSMC in the third meeting of SLSMC dated 25 th November 2025, since Government premises are not available for State Level PMU office, private premises will be rented out for State Level PMU office, this fact was brought to the attention of the committee.
Maharashtra has successfully registered 3,31,755 beneficiaries on the unified web portal under PMAY(U) 2.0.
Housing Department has successfully onboarded on SNA Sparsh portal. Centre has issued mother sanction of Rs. 246.93 crores for fund disbursement through SNA Sparsh Portal. Corresponding state fund has been reappropriated and received in January 2026. Till date, subsidy amount of center share Rs.109.85 crores and state share Rs.73.23 crores has been allocated for expenditure to the ULBs.
Maharashtra has collaborated with UNEP to promote green affordable housing right from conceptual stage of construction. UNEP will be working on three projects – Latur, Chandrapur and Ulhasnagar in the first phase for implementing Green Affordable Housing in State of Maharashtra under PMAY(U)2.0.
A total of 258 projects of 50,973 DUs is recommended for the approval of the CSMC. The committee decided to recommend the proposal of AHP and AHP-PPP projects for approval of the CSMC considering the above-mentioned conditions are fulfilled.

The proposals as listed & enclosed in 4th meeting of State Level Sanctioning and Monitoring Committee (SLSMC) of PMAY (U) 2.0 dated 2nd February 2026 recommended for approval of CSMC of PMAY (U) 2.0.

Important Observations/Directions of SLSMC

The proposed 220 BLC projects of 11,319 DUs are recommended for the approval of the CSMC.

The proposed 8 AHP projects of 4203 PMAY EWS DUs and 29 AHP-PPP projects of 26,850 PMAY EWS DUs are recommended for the approval of the CSMC. The Committee noted that certain AHP and AHP-PPP projects exceed the ASR value; however, considering that the ASR in some areas is significantly lower than the prevailing market rates, the Committee approved such projects. The projects are approved subject to the following conditions:

- Commencement of project construction shall be permitted only after achieving a minimum of 25% beneficiary attachment.
- Beneficiary attachment shall be completed within a maximum period of four (4) months from the date of issuance of the work order to the contractor/developer.
- The Government shall not bear any financial liability towards the developer/contractor for houses remaining unallotted or vacant upon completion of the project.

The proposed 1 ARH project of 8601 DUs is recommended for the approval of the CSMC provided that the project is executed following guidelines of PMAY(U) 2.0.

As was directed by the Hon. Chief Secretary and Chairman, SLSMC in the third meeting of SLSMC dated 25th November 2025, since Government premises are not available for State Level PMU office, private premises will be rented out for State Level PMU office, this fact was brought to the attention of the committee.

Maharashtra has successfully registered 3,31,755 beneficiaries on the unified web portal under PMAY(U) 2.0.


Housing Department has successfully onboarded on SNA Sparsh portal. Centre has issued mother sanction of Rs. 246.93 crores for fund disbursement through SNA Sparsh Portal. Corresponding state fund has been reappropriated and received in January 2026. Till date, subsidy amount of center share Rs.109.85 crores and state share Rs.73.23 crores has been allocated for expenditure to the ULBs.

Maharashtra has collaborated with UNEP to promote green affordable housing right from conceptual stage of construction. UNEP will be working on three projects – Latur, Chandrapur and Ulhasnagar in the first phase for implementing Green Affordable Housing in State of Maharashtra under PMAY(U)2.0.

A total of 258 projects of 50,973 DUs is recommended for the approval of the CSMC. The committee decided to recommend the proposal of AHP and AHP-PPP projects for approval of the CSMC considering the above-mentioned conditions are fulfilled.
