**READ:-** i) Govt. Circular, General Administration Department,  
No. ROB 1069/8452-O&M, dated the 24th November 1969.

iii) Government Resolution, Education, Sports & Social Welfare  
Department, No. PHE 1469/114290-C, dt. 6th May 1970.

**RESOLUTION:-** In order to ensure proper coordination and development of various activities relating to Sports, Physical Education, Youth Welfare and Youth services pertaining to student and non-student youths, including schemes such as Scouting, National Cadet Corps, National Service Corps, National Sports Organisation etc.; and in pursuance of the instructions issued in para 5 of Government Circular, General Administration Department No. ROB-1069/8452-O&M, dated the 24th Nov. 1969, Government is pleased to direct that a Directorate of Sports and Youth Services should be set up with immediate effect under the administrative control of Education, Sports and Social Welfare Department, with the Director of Sports and Youth Services as its Head. The Director of Sports and Youth Services should have the status of the Head of a Department and the Headquarters of the Directorate should be at Poona.

2. Sanction is also accorded to creation of the posts including the post of the Director of Sports and Youth Services, as mentioned in Appendix 'A' to this Resolution.

These posts should be sanctioned till the 28th February 1971, in the first instance.

3. Sanction is also accorded to the transfer of the existing staff in the Directorate of Education as mentioned in Appendix 'B', dealing with the work relating to Sports, Youth Services etc. in the Directorate of Education to the new Directorate of Sports and Youth Services with immediate effect. The Director of Education, Poona should also be requested to transfer to the Directorate of Sports and Youth Services, such of the ministerial staff in his office looking after the subjects now allotted to the Directorate of Sports and Youth Services.

4. Government is also pleased to direct as follows:-

i) The Directorate of Sports & Youth Services should deal with

the subjects mentioned in Appendix 'C'. This list of subject supercedes the list mentioned in Appendix 'A' appended to Govt. Circular, General Administration Department, No. ROB-1069/6452-O&M, dated the 24th November 1969.

- ii) The Director of Sports & Youth Services should be overall in charge of promotion of the activities pertaining to the subjects mentioned in the aforesaid list, and should work as the Ex-Officio Secretary of the State Level Boards/Committees such as:-
  - a) The State Board of Physical Education and National Fitness Corps;
  - b) The Maharashtra State Sports Council;
  - c) The State Advisory Committee for N.C.C.;
  - d) The State Youth Welfare Board for Maharashtra;
  - e) The State Advisory Committee on National Service Corps;and such other Boards/Committees which will be appointed by Government from time to time.
- iii) The Directorate of Sports and Youth Services should work in close liaison with the Directorate of Education. The Director of Sports and Youth Services should enjoy the same financial powers as the Head of a Department enjoys, as indicated in the Manual of Financial Powers, 1964, as amended from time to time, and other administrative powers delegated to the Head of a Department and such other financial, administrative and other powers, if any, as the Deputy Director of Education (incharge of Physical Education) was specifically enjoying in respect of the matters pertaining to him.
- iv) The Director of Sports & Youth Services should be the Controlling Officer so far as financial matters pertaining to his Directorate and subordinate Offices under him are concerned. The Office of the State Inspector for Physical Education, Maharashtra State, Poona, will now be a part and parcel of the Directorate of Sports and Youth Services. The Training Institute for Physical Education, Kandivali will be a subordinate office under the Director of Sports and Youth Services.
- v) The Directorate of Sports & Youth Services should have a common budget with the Education Department, with a separate sub-head under the Major Head of account "28-Education". The Director of Sports and Youth Services should accordingly submit a proposal to Government for opening of a separate sub-head under "28-Education".
- vi) The respective Departments at Sachivalaya level and the Directors at the Heads of the Departments level should transfer immediately all closed and current files including 'await cases', the dealing with those subjects, alongwith the budgetary estimates for the current year (1970-71) to this Department

Sports and Social Welfare Department) and to the Directorate of Sports & Youth Services, as the case may be, in accordance with the Principles laid down in Govt. Circular, General Administration Department, No. ROB 1069/6452-O&M, dated the 24th November 1969. In this connection attention of the Buildings & Communications Department/Home Department and the Director of Social Welfare, is particularly invited to the subjects mentioned at Sr. No. 16 ( in respect of Buildings & Communications Department), No. 13 in part and 17 ( for Home Department), and No. 18 ( for Director of Social Welfare) of the list mentioned in Appendix 'C' and they are requested to take necessary further action as indicated above.

5. Sanction is also accorded to the expenditure upto Rs. 12,000/- (Rupees twelve thousand only) being incurred on contingencies, both recurring and non-recurring, by the Directorate of Sports & Youth Services, during 1970-71.

6. The expenditure on account of the posts mentioned in appendix 'A' and on contingencies should be debited to the budget head "28-Education-F-General-S-Direction-S-4-Director of Sports & Youth Services-Demand No. 48" and should be met initially from the advance of Rs. 2,000/- ( Rupees Two thousand only) from the Contingency Fund sanctioned under Government Memorandum, Finance Department, No. CNF 1170/11/XVII, dated the 6th April 1970 as modified by Govt. Memorandum, Finance Department, No. CNF 1170/11/XVII, dated the 22nd June 1970 and dated the 13th July 1970. The Director of Sports & Youth Services should forward the necessary supplementary demand for recoupment of the advance and for the expenditure for the financial year 1970-71, in due course. The Director should also forward monthly progress of expenditure from out of the amount of the advance, to the Accountant General, Maharashtra, The Finance Department and the Education, Sports and Social Welfare Department.


7. The Director of Education, Maharashtra State, Poona should place immediately at the disposal of the Director of Sports & Youth Services the requisite grants provided for in the budget for 1970-71, in respect of the posts mentioned in Appendix 'B' and such other ministerial posts referred to in para 3 above.

8. The Director of Sports & Youth Services, should submit proposal for further continuance of posts sanctioned/transferred under this Government Resolution, in good time.

9. The orders regarding the appointment to the post of Director of Sports & Youth Services will be issued in due course.

10. This Resolution issues with the concurrence of the Finance Department vide its unofficial reference No. 999/XVII, dated the 22nd June 1970.
