Subject: Periodic review under Fundamental Rule (FR) 56(j)/(i) and Rule 48 of CCS (Pension) Rules, 1972, in respect of employees of Cantonment Boards

Please find enclosed a copy of MoD ID No.10(1)/Misc/Adm/2019-D(Q&C) dated 26.9.2019 along with a copy of DoPT OM No.25013/3/2019-Estt.A-IV dated 20.6.2019.

2. DoPT OM of dated 20.06.2019 requested to undertake the periodic reviews under Fundamental Rule 56(j)/(i) and Rule 48 of CCS (Pension) Rules, 1972, including in public sector undertakings (PSUs)/Banks and Autonomous institutions, under the administrative control of all Ministries, including MoD.

3. As per Rule 8(1)(c) of CFSR 1937 "the Board or the officer appointing a servant may discharge such servant at any time after he has attained the age of fifty five years or has completed thirty years qualified services [subject to such directions as the Central Government may issue from time to time in this regard;]." It may be seen that the provisions of Rule 56(j)(i) of FR are consistent with provisions of CFSR 1937..

4. Hence, the review of employees of the Cantonment Boards in all cases before they attain the age of 55 years or 6 months before they complete 30 years of service shall be undertaken as per the following table:-


Sl. No.	Quarter in which review is to be made	Cases of employees who will be attaining the age of 50 / 55 years or will be completing 30 years of service qualifying for pension, as the case may be, in the quarter
1.	January to March	July to September of the same year
2.	April to June	October to December of the same year
3.	July to September	January to March of the next year
4.	October to December	April to June of the next year

5. In view of above, PDsDE are directed to take necessary action for periodic review as per provisions of CFSR 1937 and existing guidelines, and submit compliance report in respect of employees of Cantonment Boards under their jurisdiction to this Dte. General within one month positively. The final report for the quarter October to December may be compiled by 20.11.2019.




