Sub. : Delegation of powers to DG DL&C to sanction the filing of appeals.

Sir,

I am directed to refer to Government letter No. 740/1/L/L&C/70/36/D (Lands), dated 7-1-1976 read with letter No. 740/1/L/L&C/70/3282/D(Lands), dated 26-4-1978, delegating powers to DG DL&C for sanctioning the Defence of Suits, appeals and other legal proceedings against Government except proceedings in the Supreme Court, and to convey the sanction of the President to the delegation to DG DL & C also the powers to sanction the filing of appeals against orders of Courts upto and including the High Courts in respect of Defence of Lands, except in cases relating to appeals against orders of Rent Controller for release of house held on hire. The delegation of powers would be subject to the following conditions :—

- (i) Advice of Ministry of Law should be obtained in each case;
- (ii) Where it is proposed not to follow the advice of Ministry of Law, the case should be referred to Government; and
- (iii) Payment of fees etc. to the Lawyers will be in accordance with the scales laid down by the Ministry of Law or approved by the that Ministry.
