Reference Govt. of India, Ministry of Defence letter No. 15(7)/2015-D(Q&C) dated 16.09.2019, on the above mentioned subject.

2. In supersession of earlier order issued vide letter dated 18.04.2016, the Government of India, Ministry of Defence vide above referred letter dated 16.09.2019 (copy enclosed as **Annexure-I** for ready reference) has now conveyed the approval of the Competent Authority for establishment of Defence Estates Office (DEO) at Itanagar by reorganising the territorial jurisdiction of DEO, Tezpur and DEO, Jorhat circles. 4. Further, the Ministry of Defence has also conveyed the sanction of the Competent Authority for de-functioning of Defence Estates Sub-Office at Bomdila as well as de-hiring of building hired for the above purposes.

5. Keeping in view of the above MoD approvals, it has been decided with the approval of the Competent Authority (Director General, Defence Estates) that the necessary action may be taken by the Principal Director, Defence Estates, Eastern Command, Kolkata for redeployment of staff to DEO, Itanagar from the other DE Circles falling within the jurisdiction of the Command, keeping in view the existing staff strength and workload in these circles. Action for staff on contract basis be also taken as per Rules.

6. Action as per para 5 above and handing taking over of records should be completed within 03 months.
7. Action for separate Budget provision be initiated urgently.
8. Further, immediate necessary action shall be taken by the concerned DEO Circle for de-functioning of Defence Estates Sub- Office at Bomdila as well as de-hiring of building hired for DE Sub-Office at Bomdila and progress in this regard may be reported immediately to this Directorate General.
9. This issues with the approval of the Director General, Defence Estates.
