Subject: — **Compassionate appointment in Defence Estates Organisation**

As per extant instructions/ guidelines for compassionate appointment under Central Government, a Departmental Committee has been constituted by the Competent Authority i.e. DG, DE to examine applications received for appointment on compassionate grounds, and submit recommendations thereon.

2.1 The above said recommendations of the ibid Committee, alongwith relaxation in accordance with extant DoP&T OM's, in upper age limit in respect of Smt. V. Bhagya(DoB - 05.05.1981), Smt. Sangita Chakraborty(DoB - 31.01.1976) and Smt. Leena Shah (DoB- 24.11.1978) for their appointment to the recommended posts, have been accepted by the Competent Authority (i.e. DG, DE).

2.2 The Departmental Committee has recommended Smt. V. Bhagya for appointment to the post of Stenographer Grade-II. However, it has been observed that Smt. V. Bhagya doesn't have the requisite/ essential stenography qualification/skill as required for appointment to the post of Stenographer Grade-II. Hence, the Case of Smt. V. Bhagya W/o Late V. Narayana Swami is being referred to Competent Authority i.e. Defence Secretary for obtaining requisite relaxation in essential stenography skill /qualification as required for the post of Stenographer Grade-II. Her case would be processed further for appointment after receipt of necessary approval of Competent Authority.

3. Based on the approval of the Competent Authority (i.e. DG, DE), the selected candidates are allocated to the following stations:-
