Sir

I am directed to say that a draft Licence Deed to be executed between the Government of India and the State Govt for transfer of cost free land by the State Govt was forwarded to the State Governments vide this Ministry letter No. 10500/NCC/ADM(A)/4447/D(CS-VI) dated 4th December, 1970.

- 2. In order to enable the Government of India to spend funds on the construction of residential accommodation for NCC staff on such land, it is necessary that some sort of wheership of land is transferred to them by the State Governments. Ministry of Law and Justice who were consulted in the matter have advised that a proper instrument for such transfer of land will be a lease deed and not a 'licence deed'.
- 3. Accordingly, a fraft lease deed has been finalised in consultation with Ministry of Law and Justice and the Director General, Defence Estates and a copy of which is forwarded herewith for adoption of the State Governments/Universities etc so as to facilitate transfer of cost free land to the Government of India, Ministry of Defence.

- (4) Every dispute, difference or question which may at any time arise between the parties hereto or any person claiming under them touching or arising out or in respect of this deed or the subject matter thereof shall be referred to the arbitration of the Chief Secretary, Govt of ______, and his decision thereon shall be final and binding on the parties.
