CORRIGENDUM

Government of India, Ministry of Defence letter No. 11011/2/77/D(Lands) dated 12.10.1977 regarding procedure for requisitioning and hiring of Immovable properties is amended as follows in so far as it relates to its application to certain cases of existing requisitioned/hired lands in the State of Jammu and Kashmir:-

(i) In Sub paras (a), (b) and (c) of para 6.

(ii) Existing sub paras (a), (b) and (c) of para 12 be substituted by the following:-

(a) Director, Defence Estates Northern Command	Rs 2,00,000/- per property
(b) Joint Director, Defence Estates, Northern Command	Rs. 1,00,000/- per property
(c) Defence Estates Officer in Northern Command.	Rs. 20,000/- per property

2. The enhanced administrative and financial powers delegated under this letter shall be exercisable by respective authorities mentioned above in respect of the land already requisitioned/hired and the land to be requisitioned/hired in future.

3. The provision of this letter shall not be applicable to the cases of requisitioned/hired lands in respect of which specific sanctions have been issued by the Ministry. Proposal for revision of rent in such cases will be submitted for obtaining Government sanction.
