Subject:- Sub-division etc. of sites held on Old Grant
terms inside Civil Areas.

Sir, I am directed to say that recently some cases have come to light, where, in pursuance of the instructions contained in the late Defence Department letter No. 11890/1/D.4, dated the 1st November 1941, and subsequently clarified in My Directorate letter No. 8/17/L/L&C/52/9212-L/52, dated the 19th November 1952, some Cantonment Boards have permitted indiscriminate sub-division of sites comprising large holdings situated inside notified civil areas held on 'Old Grant' terms, without demanding leases therefor according to no fixed rules and have thereby, in addition to congesting the area, caused loss of considerable revenue which could have been secured had the policy been judiciously and prudently followed by insisting upon execution of leases in respect of each sub-divided portions on payment of current market rent and suitable premium.

2. Government of India have given careful consideration to the matter and have decided that hereinafter change in the use of or sub-division of a site or erection of additional buildings, in respect of old grant sites inside notified civil areas, shall not be sanctioned by a Board without the previous sanction of the Central Government. All cases not yet finalised should be dealt with accordingly.

Subject:- Sanctioning of Building Plans by the

Ministry of Defence have issued orders to the
leasing of defence land to various
individuals/organisations/educational institutions
etc. for different purposes as mentioned in the
Govt. order/lease deed in the past. As BGDE is
aware, the sanction in each case is for a specific
purpose and cannot be altered without the permis-
sion of the Govt.

It has however been noticed in the recent
past that in certain cases, the Cantonment Boards
have been granting permission to use the premises
for the purposes other than for which it was san-
ctioned and has been sanctioning building plans
without obtaining the permission of the Govt. for

the change of purpose. This is a serious lapse on
the part of the Cantonment Boards and should not be
allowed to happen hereafter. BGDE and accordingly
requested to issue strict instructions to all
Cantonment Boards not to sanction any building
plans excepting the additions and alterations to
the existing buildings which does not alter the purpose
for which the lease was granted unless the request
for change is accepted by the Govt. The Institute
may also specifically state that the viola-
tion of the same would be treated seriously and
action will be taken against the concerned

action as deemed fit would be taken against the officials responsible. A copy of instruction so issued may also be forwarded to this Ministry.

Subject - Sanctioning of Building Plans by the
Cantonment Board.

Ministry of Defence have issued orders to the lessing of defence land to various individuals/organisations/educational institutions etc. for different purposes as mentioned in the Govt. order/lease deed in the past. As DGDE is aware, the sanction in each case is for a specific purpose and cannot be altered without the permission of the Govt.

2. It has however been noticed in the recent past that in certain cases the Cantonment Boards have been granting permission to use the premises for the purposes other than for which it was sanctioned and has been sanctioning building plans without obtaining the permission of the Govt. for the change of purpose. This is a serious lapse on the part of the Cantonment Boards and should not be allowed to happen hereafter. DGDE are accordingly requested to issue strict instructions to all Cantonment Boards not to sanction any building plans excepting the additions and alterations to the existing buildings which does alter the purpose for which the lease was granted unless the request for change is accepted by the Govt. The instructions may also specifically state that the violation of the same would be viewed seriously and action as deemed fit would be taken against the Officers responsible. A copy of instruction so issued may also be forwarded to this Ministry.
