Subject : Land Audit.

Sir,

Considering the importance of land as a national resource, it has been decided that conduct of land audit will be resumed. The land audit shall be conducted by DGDE covering the following areas:-

- (i) Updating of land records;
- (ii) Survey and demarcation and protection of defence lands by way of erection of boundary pillars and tallying the records with ground reality;
- (iii) State of computerization of land records;
- (iv) Efficient usage of defence lands;
- (v) Encroachments on defence lands, the extent and reasons thereof, effectiveness of encroachment removal actions;
- (vi) Verify the usage of defence lands on lease to institutions.

2. A Land Audit Cell will be opened in DGDE to undertake the task.

3. The Land audit cell will prepare year-wise plan of audit. A copy of plan will be submitted to the Ministry. To start-with, DGDE shall first, carry-out land audit in Southern Command from the current financial year (2011-12).
