Subject : TRANSFER OF LAND FOR SETTING UP KENDRIYA
VIDYALAYAS - DELEGATION OF POWERS TO GOC-
IN-C COMMAND HQRS.

The Govt. of India, Ministry of Defence vide their letter No.3(4)/85/1900-B/D(GS-II)/85, dated 15th July, 1985 has delegated powers to GOC-in-Chief of the Command for issue of orders regarding leasing out of defence lands to Kendriya Vidyalaya Sangathan for establishing Central Schools thereon subject to conditions given thereon. The Govt. have since issued a corrigendum vide their letter No.3(4)/85/59-B/D(GS-II), dated 9th January, 1986 according to which similar powers have also been delegated to you for issue of orders regarding leasing out of defence lands under your control and management to Kendriya Vidyalaya Sangathan.

In the case of leasing of Army lands to Kendriya Vidyalaya Sangathan, the following procedure, as suggested by us, is being followed by HQ SC Poona.

(i) In all cases of lease of land to Kendriya Vidyalayas Station Commander should convene a Board of Officers to assess the requirement of land and KVS Authorities as well as the Defence Estates Officer should be associated with the Board.

(ii) The Board Proceedings should be forwarded to the GOC-in-Chief through Staff Channels along with a Statement of Case justifying the minimum requirement of land.

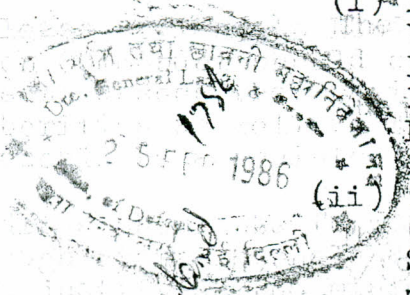
(iii) Board Proceedings should be accompanied by a Certificate from the Station Commander that the land can be spared.

(iv) Certificate regarding land being defence-owned should be obtained from DEO and attached to the Board Proceedings. A copy of GLR Extract/MLR extract should also be attached. The site plan showing the land proposed for lease should also be attached to the Board Proceedings.

(v) The maximum permissible area is 18 acres. The minimum requirement should be justified by the Station Commander while forwarding the case.

(vi) Orders of the GOC-in-Chief may be obtained and the file referred to us for issue of sanction.

(vii) The Board Proceedings shall be forwarded to the GOC-in-Chief through Staff Channels along with a Statement of Case justifying the minimum requirement of land. The site plan showing the land proposed for lease should also be attached to the Board Proceedings.2/-
