S.O 23 (E)- In exercise of the powers conferred by clause(2) of article 77 of the Constitution, the President hereby makes the following rules further to amend the Authentication (Orders and other Instruments) Rules, 1958, namely :

1. (1) These rules may be called the Authentication (Orders and other Instruments) Amendment Rules, 1973.
