2. The offer of appointment be sent by e-mails apart from usual channels of communication on the e-mail addresses given by the candidates in the dossiers.

3. Being the Appointing Authority for the post of Sub-Divisional Officer Grade-II, carrying Level-4 of the pay matrix (Group 'C' post), the Directorates, Defence Estates, are directed to verify the following particulars/ documents of each of the candidate(s) comprehensively prior to issuing offer of appointment to the candidates:

- (i) Date of Birth
- (ii) Essential Qualification as on the crucial date.
- (iii) Age relaxation claimed by candidate(s), if any.
- (iv) SC/ST/OBC/EXs/PH Certificate issued by the Competent Authority.
- (v) In respect of OBC candidate(s) the extent guidelines regarding Creamy layer status may be followed strictly.
- (vi) The genuineness of OBC certificate indicating Non-Creamy Layer status issued by the prescribed authorities need to be verified.
- (vii) Photo, Signature, LTI and educational qualification documents provided with the dossiers of the candidates need to be verified with those the candidate(s) may actually submit at the time of joining the service.

3.1 In addition to the above, concerned Appointing Authorities are also requested to ensure following actions at their end:

- (i) Directorates/DEOs concerned may carry out all pre-appointment formalities such as Character and Antecedent Verification & Medical Examination, etc. of the candidate(s) as per extant Rules and Regulations of the Government.
- (ii) In case where offer of appointment formalities has been sent to the candidate(s) and the candidate(s) has sought extension of time of joining the post, the same may be considered by the Directorates concerned in accordance with the guidelines contained in DoP&T OM No. 9/23/71-Estt.(D) dated 06.06.1978 and OM No. 350/5/2/93-Estt(D) dated 09.08.1985.
- (iii) If any candidate declines the offer of appointment or fails to report for duty, or there is no response from him/her even after reminder(s) (through speed/registered post with acknowledgement due), the offer of appointment should formally be cancelled under intimation to this Dte. General and the candidate informed accordingly.
- (iv) Offer of appointment to the selected candidates(s) should be issued at the earliest possible so that they need not have to wait for unduly long period and also the vacancies in question are filled expeditiously.

4. The original dossiers of the above named candidates against Sub-Divisional Officer Grade-II posts, allocated to various offices may be forwarded by Dte. DE, SC, Pune to the concerned Directorate(s)/offices for further necessary action at their end. A sample appointment letter in this regard is attached herewith for facilitating the early issuance of appointment letters to the above mentioned candidates.

5. **Appointment letter to the candidate mentioned at sr. no. 85 above i.e. Shri Asit Biswas, should only be issued after due verification of his caste certificate from concerned Competent /issuing Authority.**
