**Subject: PLACING SERVICES OF SHRI B REDDY SANKAR BABU (IDES: 1998), JT. DIRECTOR, NIDEM, DELHI CANTT. AT THE DISPOSAL OF STATE GOVERNMENT OF KARNATAKA ON DEPUTATION BASIS**

Govt. of India, Ministry of Defence vide ID No. 15(7)/IDES/CC/2019-D(Q&C) dated 15.12.2020 has conveyed the cadre clearance of Competent Authority for deputation of Shri B Reddy Sankar Babu (IDES: 1998) with State Government of Karnataka as per guidelines issued vide DoP&T OM No. 2/6/2018-Estt.(Pay-II) dated 18.05.2018.

2. The State Government of Karnataka has further requested to relieve Shri B Reddy Sankar Babu immediately to take up his new assignment on deputation with State Government of Karnataka. Accordingly, it has been decided with the approval of DG DE that Shri B Reddy Sankar Babu, may be relieved w.e.f. 31.12.2020 (A/N) to take up his new assignment in the State Government of Karnataka.

3. During the period of deputation, the officer is entitled to draw his pay and allowances in the pay level-14 as per 7<sup>th</sup> CPC matrix table presently drawn by him. The deputation of Shri B Reddy Sankar Babu will be governed by terms and conditions laid down by DoP&T OM No. 6/8/2009-Estt.(Pay II) dated 17.06.2010 as amended from time to time. The leave salary during the period of deputation of the officer will be paid by State Government to the Principal Controller of Defence Accounts (PCDA), HQrs, 'G', Block, New Delhi-110011. Further, the monthly contributions of the officer to Central Government Employee Group Insurance Scheme (CGEGIS) deducted from his salary will be sent by State Government, Karnataka to the PCDA, HQrs. Besides this, the GPF deductions from the salary of

the officer will be sent to the Controller of Defence Accounts (Funds), Meerut Cantt. for crediting it into the GPF A/c No. 01410917 of Shri B Reddy Sankar Babu, IDES.

4. Compliance of this order will be reported to this Directorate General immediately after the event.
