Subject: Promotion to the Senior Administrative Grade [Pay Scale in Level-14 pre-revised Pay Scale of ₹ 37,400 - 67,000 (PB-4) with Grade Pay of ₹ 10,000/-] in the Indian Defence Estates Service.

The Appointments Committee of the Cabinet, based on the recommendations of the Departmental Promotion Committee, has approved empanelment of the following officers of Indian Defence Estates Service (IDES) for promotion to Senior Administrative Grade (SAG) in the Pay Level-14 [pre-revised Pay Scale of Rs 37,400-67,000 (PB-4) with Grade Pay of Rs 10,000/-] for the panel year 2020 with effect from the date of assumption of the charge of the post, and until further orders, subject to the outcome of OA No. 170/01055/2019 pending before the CAT, Bangalore Bench:-

- (i) Shri Navendra Nath
- (ii) Shri Yogesh Kumar
- 2. As assessment in respect of Shri N. Srinivasa Reddy had been kept in the 'sealed cover', the ACC has approved promotion of junior most officer in the panel (Shri Yogesh Kumar) on 'ad-hoc' basis, till the 'sealed cover' case in respect of Shri Reddy is finalized or subsequent regular vacancies in the grade arises, whichever is earlier.
- **3**. Considering the above facts, the above named officers are promoted to the Senior Administrative Grade (SAG) in the Pay Level-14 [pre-revised Pay Scale of Rs 37,400-67,000 (PB-4) with Grade Pay of Rs 10,000/-] with effect from the date of assumption of charge in the higher appointment and until further orders. However, in accordance with the para 2 above, the promotion of Shri Yogesh Kumar to SAG, would be on 'ad-hoc' basis.

- **4**. Further, the promotion of above named officers to Senior Administrative Grade(SAG), is subject to the outcome of the OA No. 1055/2019 pending before learned Central Administrative Tribunal, Principal Bench, Delhi.
- **5**. As a sequel to the above, the following transfers/postings are ordered with the approval of the Competent Authority (Hon'ble Raksha Mantri):-
  - (a) **Shri Navendra Nath (IDES:1990)**, Chief Executive Officer, Cantonment Board, Meerut, on his promotion to SAG, is transferred and posted as Director in the Directorate of Defence Estates, Southern Command, Pune, against an existing vacancy; and
  - (b) Shri Yogesh Kumar (IDES:1998), Deputy Director General in the Directorate General of Defence Estates, Delhi Cantt, on his 'ad-hoc' promotion to SAG, is transferred and posted as Director in the Directorate of Defence Estates, Western Command, Chandigarh, against an existing vacancy.
- **6**. Suitable administrative arrangement for the post of CEO, Cantonment Board, Meerut, vice Shri Navendra Nath being transferred and posted to Pune, are being issued separately.
- **7**. TA/DA and joining time will be admissible as per Rules.
- **8**. The dates of assumption of duties shall be intimated to this Directorate General immediately.
- 9. This issues with the approval of the Director General, Defence Estates.
