Subject: Grant of Non-Functional Upgradation to officers of Indian Defence Estates Service in Senior Administrative Grade (SAG) in the Pay Level-14 [pre-revised Pay Scale of ₹37,400-67,000/- (PB-4) with Grade Pay of ₹10,000/-].

A meeting of Departmental Screening Committee (DSC) under the Chairmanship of Defence Secretary was held to consider eligibility of Shri K. Lhouvum, IDES:1988 (now Retd) for grant of Non-Functional Upgradation (NFU) to Senior Administrative Grade (SAG) in the Pay Level-14 [pre-revised Pay Scale of ₹37,400 −67,000/- (PB-4) with Grade Pay of ₹10,000/-] in terms of DoP&T O.M. No. AB.14017/64/2008-Estt.(RR) dated 24.04.2009. The DSC after assessing the fitness of the officer for the year 2015-16, 2016-17, 2017-18, 2018-19, 2019, 2020 and 2021 and has recommended for grant of Non-Functional Upgradation to SAG to Shri K. Lhouvum w.e.f. 01.01.2021. The recommendations of the DSC have been accepted by the Competent Authority.

- 2. Accordingly, Non-Functional Upgradation (NFU) to Senior Administrative Grade (SAG) in the Pay Level-14 [pre-revised Pay Scale of ₹37,400 67,000/- (PB-4) with Grade Pay of ₹10,000/-] is granted to **Shri K. Lhouvum (IDES:1988)**, with effect from **01.01.2021**.
- **3**. The above upgradation, as per DoP&T OM No. AB.14017/64/2008-Estt.(RR) dated 24.04.2009, is purely non-functional, personal to the officer and would not bestow any right to him for claiming promotion benefits.

- **4.** Pay fixation on grant of Non-Functional Upgradation will be done as per the provisions of CCS(RP) Rules, 2008 and CCS(RP) Rules, 2016 and clarifications, as issued there upon by DoP&T from time to time.
