2. As, presently there is only 01 vacancy available in HAG of IDES and the senior most officer on the approved panel, namely, Shri A.V. Dharma Reddy who is presently on deputation outside the Cadre, has conveyed his unwillingness for premature repatriation from deputation to the Cadre for availing promotion to HAG, therefore, next officer on the approved panel, namely, Shri Anuj Sharma (IDES:1991) is promoted on 'ad-hoc' basis to the Higher Administrative Grade (HAG) in Level-15 of the Pay Matrix (pre-revised Pay Scale of ₹ 67,000 – 79,000/-) w.e.f. the date of assumption of charge in the higher appointment and until further orders.

3. Consequent to the above, Shri A.V. Dharma Reddy, presently on deputation with State Government of Andhra Pradesh, is granted Pro forma Promotion to the Higher Administrative Grade (HAG) in Level-15 of the Pay Matrix (pre-revised Pay Scale of ₹ 67,000 – 79,000/-) under Next Below Rule (NBR) with effect from the date his junior, namely, Shri Anuj Sharma, draws officiating pay in that scale.

In view of the above and with the approval of the Competent Authority (Hon'ble Raksha Mantri), **Shri Anuj Sharma (IDES-1991)**, Additional Director General, Defence Estates, Delhi Cantt, upon promotion to HAG, is transferred and posted as Principal Director, Defence Estates, Northern Command, Jammu, against an existing vacancy
