**Subject: Promotion to the Senior Administrative Grade [Pay Scale in Level-14 pre-revised Pay Scale of ₹ 37,400 – 67,000 (PB-4) with Grade Pay of ₹ 10,000/-] in the Indian Defence Estates Service.**


The Appointments Committee of the Cabinet, based on the recommendations of the Departmental Promotion Committee, has approved empanelment of Smt. Bhavana Singh (IDES:1993) for promotion to Senior Administrative Grade (SAG) of Indian Defence Estates Service (IDES) in the Pay Level-14 [pre-revised Pay Scale of Rs 37,400-67,000 (PB-4) with Grade Pay of Rs 10,000/-] with effect from the date of assumption of the charge of the post, and until further orders.

2. As assessment in respect of officers senior to Smt. Bhavana Singh, had been kept in the 'sealed cover(s)', the ACC approved promotion of Smt. Bhavana Singh is on 'ad-hoc' basis, till the sealed cover cases are finalized or subsequent regular vacancies in the grade arise, whichever is earlier.

3. Considering the above facts, Smt. Bhavana Singh (IDES:1993) Defence Estates Officer, Meerut, is promoted on 'ad-hoc' basis to the Senior Administrative Grade (SAG) in the Pay Level-14 [pre-revised Pay Scale of Rs 37,400-67,000 (PB-4) with Grade Pay of Rs 10,000/-] notionally w.e.f. 11.05.2020 and actually from the date of assumption of charge in the higher appointment and until further orders.

4. Consequent to the above and with the approval of the Competent Authority (Hon'ble Raksha Mantri), Smt. Bhavana Singh (IDES:1993), Defence Estates Officer, Meerut, on her 'ad-hoc' promotion to SAG, is transferred and posted as Director in the Directorate of Defence Estates, Central Command, Lucknow, against an existing vacancy.

5. Further, the ibid promotion of Smt. Bhavana Singh to Senior Administrative Grade(SAG), is subject to outcome of the OA No. 1055/2019 pending before learned Central Administrative Tribunal, Bangalore Bench/Delhi Bench.
6. The posting of Defence Estates Officer, Meerut, vice Smt. Bhavana Singh, is being issued separately.
7. TA/DA and joining time will be admissible as per Rules.
8. The dates of assumption of duties shall be intimated to this Directorate General immediately.
