In compliance of learned Central Administrative Tribunal, Principal Bench, New Delhi order dated 25.08.2015 passed in OA No. 25.08.2015 and Order dated 27.10.2015 passed in OA No. 1897/2013 read with common judgment dated 20.02.2020 passed by Hon'ble High Court of Delhi in WP(C) No. 7279/2016 & 10815/2016, a Meeting of Review Departmental Screening Committee (R-DSC) was held by circulation of papers to review the recommendations of earlier DSC relating to Shri Sudhir Chopra, IDES-1980 (now Retd) for grant of Non-Functional Upgradation (NFU) to Senior Administrative Grade (SAG) in the pre-revised Pay Scale of ₹37,400-67,000/- (PB-4) with Grade Pay of ₹10,000/-. The said R-DSC, considered the eligibility of Shri Sudhir Chopra in terms of DoP&T OM No. AB. 14017/64/2008-Estt.(RR) dated 24.04.2009 and recommended for grant of NFU to SAG level w.e.f. 03.01.2006 to him.

The ibid recommendations of the R-DSC having been accepted by the Competent Authority, Non-Functional Upgradation to Senior Administrative Grade (SAG) in the pre-revised Pay Scale of ₹37,400-67,000/- (PB-4) with Grade Pay of ₹10,000/-, is granted to Shri Sudhir Chopra, IDES-1980 (now Retd) w.e.f. 03.01.2006.
- **3**. The above upgradation is purely non-functional, personal to the officer and it would not bestow any right to the officer to claim promotion or deputation benefits for the period of his service.
