## Subject: Promotion to the Senior Administrative Grade [Pay Scale in Level-14 pre-revised Pay Scale of ₹ 37,400 – 67,000 (PB-4) with Grade Pay of ₹ 10,000/-] in the Indian Defence Estates Service.
