The 58th NDC Course at National Defence College, New Delhi is scheduled to commence from 8th January, 2018 to 30th November, 2018. The duration of the course is 47 weeks. A few seats at the NDC Course are Civilian Officers earmarked for the belonging Ministries/Departments.

- The broad objective of the NDC Course is to provide a holistic view of contemporary economic and political scenarios and related aspects with particular emphasis on security issues. A better understanding among professionals drawn from different disciplines in the country having divergent backgrounds and value is yet another objective of the course. Visits to important military stations and frontier posts and some foreign countries from integral part of the course curriculum.
