**Subject: Selection of Shri Abhijit Vishnu Sanap (IDES), Chief Executive Officer, Kamptee, Cantt Board for appointment to the post of Director in NDMC on deputation-reg.**

Reference NDMC Letter No. SO(E)/100/Estt./2023 dated 17.02.2023 & MoD ID No. 15(7)/IDES/AS/2019-D(Q&C) dated 01.03.2023 on the subject matter.

2. The Competent Authority, in New Delhi Municipal Council (NDMC) has approved selection of Shri. Abhijit Vishnu Sanap (IDES), Chief Executive Officer, (Pay Level-11, 7th CPC) for appointment as Director, in NDMC on deputation basis in the (pre-revised) pay (Rs.78800-209200) initially for a period of three (03) years from the date of joining in NDMC on usual terms and conditions of deputation stipulated by DOP&T.

Consequent upon the selection of the Officer for the said post the leave salary during the period of deputation of the officer will be paid by New Delhi Municipal Council (NDMC) to the Principal Controller of Defence Accounts (PCDA), HQrs, New Delhi. Further, the monthly contributions of the officer to Central Government Employees Group Insurance Scheme (CGEIS) deducted from his salary and the NPS contributions from the salary of the officer as well as contribution by Government will be sent to PCDA, HQrs.
4. Shri Abhijit Sanap may be relieved immediately to enable him to take up his new assignment in the NDMC, New Delhi.

5. Orders for transfer/posting of suitable officer to fill the ensuing vacancy for the post of CEO, Cantt. Board, Kamptee will be issued separately in due course of time. Till posting of regular incumbent suitable administrative arrangement to look after the duties of CEO, Cantt. Board, Kamptee may be made by Principal Director, DE, Southern Command, Pune under intimation to this Dte. General.
