**Subject: Promotion of Civilian Motor Driver (Grade-I) to the post of Civilian Motor Driver (Special Grade) Group-'B' (Non-Gazetted) in the pre-revised pay scale of Rs. 9300-34800 with grade Pay of Rs. 4200 (now Level-6 of the pay matrix as per 7th CPC).**

The meeting of Departmental Promotion Committee (DPC) was held to consider the promotion of eligible Civilian Motor Driver (Grade-I) of Defence Estates Organization to the post of Civilian Motor Driver (Special Grade) in the pre-revised pay scale of Rs. 9300-34800 with Grade Pay of Rs. 4200/-(Level-6) of the revised pay matrix as per 7<sup>th</sup> CPC) for the vacancy years 2011-12, 2012-13, 2013-14, 2014-15, 2015-16, 2016-17, 2017-18, 2018-19, 2019, 2020, 2021, 2022 & 2023. The said DPC after assessment of suitability of the concerned official has recommended **Shri D K Pathak**, Civilian Motor Driver (Grade-I) of this Dte General for promotion to the post of Civilian Motor Driver (Special Grade) in the pay level-6 (pre-revised pay scale of Rs. 9300-34800 with Grade Pay of Rs. 4200/-) for the panel year 2023.

2. The aforesaid recommendations of the DPC have been accepted by the Competent Authority.
3. Considering the above facts, **Shri D K Pathak**, Civilian Motor Driver (Grade-I) is granted in-situ promotion to the post of Civilian Motor Driver (Special Grade) Group-'B' (Non-Gazetted) in the pre-revised pay scale of Rs. 9300-34800 with Grade Pay of Rs. 4200/-(Level-6 of the revised pay matrix as per 7<sup>th</sup> CPC), with effect from the date of assumption of duties in the promoted grade, against the vacancy available at this Dte General.
4. The above named official shall submit his acceptance / refusal of promotion to this Directorate General within 07 days of receipt of this order. In case, no intimation is received within the prescribed time limit it will amount to be deemed refusal by the official concerned, and promotion orders will be cancelled forthwith. If the above named official refuses his

promotion as Civilian Motor Driver (Special Grade), he will be debarred from promotion for one year and will not be entitled for financial upgradation under MACP Scheme 2009 as per extant rules.
