Promotion of Sub Divisional Officer Grade-II(SDO-II) to the post of Sub Divisional Officer Grade-I(SDO-I) in the pre-revised pay scale of Rs. 9300-34800 with grade Pay of Rs. 4200(now Level -6 of the pay matrix as per 7th CPC).

A Departmental Promotion Committee (DPC) meeting was held to consider the promotion of Sub Divisional Officer Grade-II (SDO-II) to the post of Sub Divisional Officer Grade-I (SDO-I) in the pre-revised pay scale of Rs. 9300-34800 with Grade Pay of Rs. 4200/-(now Level-6 of the pay matrix as per 7th CPC) for the vacancy years 2022 and 2023.
