Promotion of Lower Division Clerk (LDC) to the post of Upper Division Clerk (UDC) in the pre-revised pay scale of Rs. 5200-20200 with Grade Pay of Rs. 2400/-(now Level-4 of the pay matrix as per 7th CPC).

A Departmental Promotion Committee (DPC) meeting was held to consider the promotion of Lower Division Clerk (LDC) to the post of Upper Division Clerk(UDC) in the pre-revised pay scale of Rs. 5200-20200 with Grade Pay of Rs. 2400/-(now Level-4 of the pay matrix as per 7th CPC) for the vacancy years 2020, 2021, 2022 and 2023.

2. - 4. Accordingly, post of LDC held by the above employees would be abolished in terms of para 6 of Govt. of India, Min. of Defence Order bearing No. 15(15)/2002/D(Q&C)-Vol II, dated 06.03.2009 after assuming the charge of UDC by the above named officials in higher grade.
- 5. The above officials shall submit their acceptance / refusal of promotion to this Directorate General within 07 days of receipt of this order. In case, no intimation is received within the prescribed time limit, it will amount to be deemed refusal by the official concerned, and promotion orders will be cancelled forthwith. If any of the above named officials refuse their promotion as Upper Division Clerk, he /she will be debarred from promotion for one year and will not be entitled for financial upgradation under MACP Scheme 2009 as per extant rules. This may please be brought to the notice of the concerned officials. Further, it may be ensured that the communication regarding acceptance/ refusal of promotion must reach this Dte. Gen. within 07 days of publishing of this order on the official website of DG DE.
- 6. The Directorates/ concerned offices are also advised to ascertain that the concerned official is clear from vigilance angle before placing them in the promotional post of UDC.
- 7. The dates of assumption of duties in the higher grade by the above named officials shall be intimated to this Directorate General immediately after the said event.
- 8. All the concerned subordinate offices including Directorates, DEO/ ADEO offices are also directed to suitably amend their Establishment Return as per the above allocation/transfer/posting of the incumbents.
