- 5. The officials who have been promoted to the post of OS, shall submit their acceptance / refusal of promotion to this Directorate General within 07 days of receipt of this order. In case, no intimation is received within the prescribed time limit it will amount to be deemed refusal by the official concerned, and promotion orders will be cancelled forthwith. If any of the above named officials refuse their promotion as OS, he /she will be debarred from promotion for one year and will not be entitled for financial upgradation under MACP Scheme 2009 as per extant rules. This may please be brought to the notice of the concerned officials. Further, it may be ensured that the communication regarding acceptance/ refusal of promotion must reach this Directorate General within 07 days of issuance of this order on the official website of DG DE.
- **6.** The Directorates/concerned offices are also advised to ascertain that the concerned official is clear from vigilance angle before placing them in the promotional post of OS.
- **7**. The dates of assumption of duties in the higher grade by the above named officials shall be intimated to this Directorate General immediately after the said event.
- **8**. All the concerned subordinate offices including Directorates, DEO/ ADEO offices are also directed to suitably amend their Establishment Returns as per the above allocation of posts.
