2. Detailed instructions have been issued from time to time for regular monitoring of court cases, timely submission of proposals for seeking opinion of LA(Def) on court orders, obtaining sanction for payment of enhanced compensation under Charged Head after litigation attained finality and taking follow up actions by the concerned DEOs/Dte. DE. It has also been emphasized that the contempt cases and execution cases also need to be attended/monitored with utmost care as per instructions issued.

3. It is reiterated that the primary responsibility of defence/follow up of the cases on behalf of the UoI rests with DEOs & CEOs to ensure that the written statements/counter affidavits/appeals etc in the cases are filed timely and court cases are properly defended by the Govt. Counsel. All actions like prior briefing of the counsel/Ld. ASGI/DSGI, attendance during the hearing, ensuring timely service of dasti notices, obtaining stays etc. (wherever required) need to be taken scrupulously to ensure that the cases are well defended.

4. It is once again emphasized that all court cases (particularly contempt & execution cases) are regularly & properly monitored personally by the CEOs & DEOs as the case may be. PDs, DE are requested to instruct all DEOs/CEOs to

Strictly follow the instructions issued from time to time and ensure that Govt. interest is protected effectively.

5. As already instructed all contempt cases and execution cases shall be monitored by the nodal officers in the Dte. offices at their level regularly and appropriate action may be taken by them for proper defence of court cases with approval of PDDE. Periodic report be sent to Dte. General as per instructions issued.

6. This issues with the approval of DGDE.
