

2. In continuation to this Dte. General letters under reference, the following additional steps shall also be taken by all the DEOs/CEOs/ADEOs for defending the court cases effectively:-

- (i) In all sensitive cases, as also in cases where the orders have been passed in favour of UOI, Caveat Petitions should be filed by the DEO on behalf of UOI to avoid any adverse orders being issued by the court without giving opportunity of hearing to UOI.
- ii) It is observed that in some cases where a common judgment has been pronounced in respect of number of cases, Appeal/SLP has been filed against one case instead of all cases decided vide the common judgment. It is to be ensured by the PDs DE, that appeals/SLP are filed impleading petitioners in all cases that had been decided by common Judgment in consultation with MoL/LA (Def)/Addl. ASG, by adding all of them in the memo of parties or otherwise.
