- Consequent upon setting-aside of the penalty order dated 01.06.2017 by the learned Central Administrative Tribunal, Principal Bench, New Delhi vide its order dated 19.09.2023 passed in OA No. 3672/2017, which was also upheld by the Hon'ble High Court of Delhi vide its judgment dated 23.08.2024 passed in WP (C) No.10058/2024, the sealed cover containing the assessment and recommendations of the Departmental Promotion Committee (DPC) dated 05.02.2010 in respect of Shri Ajay Kumar Choudhary (IDES:1997), for his promotion from Senior Time Scale (STS) to Junior Administrative Grade (Ordinary Grade) in the Pay Matrix Level-12 [pre-revised pay scale of ₹ 15,600-39,100 (PB-3) with Grade Pay of ₹7,600/-], for the vacancy year 2009-10, was opened with the approval of the Competent Authority.
- 3. The ibid DPC has assessed Shri Ajay Kumar Choudhary as FIT for promotion to Junior Administrative Grade (Ordinary Grade) and recommended for inclusion of his name in the panel for the year 2009-10 at Sl. No. 5-A below Ms. Sujatha Gupta (Sl. No. 5) and above Ms. Vibha Sharma (Sl. No. 6).

Based on the ibid recommendations and with the approval of the Competent Authority, Shri Ajay Kumar Choudhary (IDES-1997), presently posted as Deputy Director in the Directorate of Defence Estates, South-Western Command, Jaipur, is promoted in-situ to Junior Administrative Grade (Ordinary Grade) in the Pay

Matrix Level-12 [pre-revised pay scale of ₹ 15,600-39,100 (PB-3) with Grade Pay of ₹7,600/-] of the Indian Defence Estates Service, **notionally w.e.f. 15.02.2010** i.e. the date of promotion of his immediate junior, named, Ms. Vibha Sharma and actually from the date of assumption of charge in the promoted grade. The subject promotion is without prejudice to Government rights.

- **5.** Consequent upon promotion, the inter-se seniority of Shri Ajay Kumar Choudhary in the Junior Administrative Grade of Indian Defence Estates Service for the year 2009-10 onwards, is fixed below Ms. Sujatha Gupta, IDES:1997 (now Retd.) and above Ms. Vibha Sharma, IDES:1997.
