Subject: Promotion of Private Secretary (PS) Group-B (Gazetted) to the post of Senior Private Secretary (SPS) Group-B (Gazetted) in Level-8 of the pay matrix as per 7th CPC).

- 2. The aforesaid recommendations of the DPC have been accepted by the Competent Authority.
- 3. Considering the above facts, the above named Private Secretaries (PS) Group-B (Gazetted) in Level-7 are granted promotion to the post of Senior Private Secretary (SPS) Group-B (Gazetted) in Level-8 of the revised pay matrix as per 7<sup>th</sup> CPC, in order of seniority reflected in year-wise panels, with effect from the date of assumption of duties in the promoted grade.
- 4. Consequent upon promotion to the post of Senior Private Secretary (SPS) and keeping in view the administrative exigencies as well as public interest, the following postings are ordered with the approval of the Competent Authority (Director General, Defence Estates):-

- **5**. The concerned officials may be considered for transfer / posting along with others whenever routine transfer / posting of officials is proposed.
- **5.1**. The above named officials shall submit their acceptance / refusal of promotion to this Directorate General within 07 days of receipt of this order. In case, no intimation is received within the prescribed time limit it will amount to be deemed refusal by the official concerned, and promotion orders will be cancelled forthwith. If any of the above named officials refuses promotion as SPS, he /she will be debarred from promotion for one year and will not be entitled for financial upgradation under MACP Scheme 2009 as per extant rules. This may please be brought to the notice of the concerned officials. Further, it may be ensured that the communication regarding acceptance/ refusal of promotion reaches this Directorate General within 07 days of issuance of this order on the official website of DG DE.



- 6. <u>The Directorates/concerned offices are also advised to ascertain that the concerned officials are clear from vigilance angle before placing them in the promotional post of SPS.</u>
- 7. The dates of assumption of duties in the higher grade by the above named officials shall be intimated to this Directorate General immediately after the said event.
- **8**. All the concerned Directorates are also directed to suitably amend their Establishment Return as per the above allocation of officials.
