2.1. Recommendations of DSC in respect of Smt. Amarjeet Kaur, SDO-I of ADEO Baramulla office have been placed under sealed cover due to pending departmental / criminal proceedings against her.

2.2. Case of MACP in respect of Shri V. B. Gadre, SDO-I of DEO Mumbai, has been delinked from instant proposal due to lack of requisite information / documents with respect to below benchmark gradings out of reckonable APARs and unauthorized absence of the official concerned. Separate correspondence in this regard is being made with concerned Directorate. Case of the said official would be assessed by DSC after receipt of requisite information / documents from concerned Directorate.

3. The financial up-gradation under the MACPS shall be purely personal to the employees, and shall have no relevance to their seniority. As such, there shall be no additional financial up-gradation for the senior employees on the ground that the junior employee in the grade has got higher pay/grade pay under the MACPS. Further, there shall be no change in the designation, classification and status of the employee.

4. With regard to fixation of pay on grant of financial up-gradation under MACPS, a Govt. servant has an option under FR 22(a)(1) to get his pay fixed in the higher grade pay, either from the date of his up-gradation or from the date of his next increment i.e. 1st July/1st Jan of the relevant year. The pay and the date of increment would be fixed in accordance with clarification No. 2 contained in Deptt. of Expenditure O.M. No. 1/1/2202-IC dated 13.09.2008, No. 35034/3/ 2008-Estt. (D) dated 16.11.2009 and No. 11 of O.M. No. 35034/3/2008-Estt. (D) dated 09.09.2010.

5. <u>The concerned Heads of Offices are advised to re-verify service records of the above named employee(s) before processing case(s) for pay fixation with the concerned audit authorities. Any discrepancy pertaining to service details of the employees should be brought to the notice of this Directorate General within 15 days from the date of issue of this order.</u>
