**Subject: Transfers/posting of Group 'A' Officers of Indian Defence Estates Service – Below JAG.**


Keeping in view the administrative exigencies as well as public interest and with the approval of the Competent Authority (Director General, Defence Estates), the following transfers/postings are ordered with immediate effect:
