Subject: Transfers/posting of Group 'A' Officers of Indian Defence Estates Service - Below SAG level

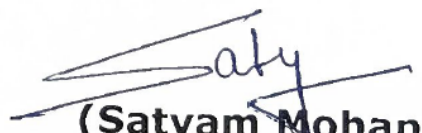
