SEVEN DAYS AWARENESS CAMP FOR SEVEN DIFFERENT CATEGORIES OF WORKERS IN UNORGANIZED SECTOR



The Indian economy is characterized by the existence of a vast majority of unorganized labour employment. Unorganized or informal sector constitutes an important part of Indian economy. The prominent features of the sector are lower real wages and poor working /living conditions. Further, the unorganized sector is characterized by excessive seasonality of employment, preponderance of casual and contractual

employment, negation of social standards and work rights, denial of minimum wages and so on. The insecurities and vulnerabilities of this unorganized sector labour are on the rise. Workers in the unorganized sector are usually subject to indebtness and bondage as their meager income cannot meet with their livelihood needs. The unorganized labour, by and large, remains unaware of the various welfare labour laws and welfare labour schemes meant for them. The District Legal Services Authority, Faridabad organized awareness campaign for the unorganized sector with the objective to spread maximum awareness amongst the workers of unorganized sector. This campaign was organized with

Department. In the said campaign, the workers consisting of Mason, Carpenters, Electricians and workers such as Rickshaw pullers, Brick Kiln workers etc. were made aware of the various welfare laws and schemes meant for them. They were also explained the concept of free legal aid. The Haryana State Legal Services Authority has made compilation of the welfare schemes related to unorganized worker in vernacular language.




SPECIAL LEGAL LITERACY CAMPS FOR OFFICIALS AT GRASS ROOT LEVEL

NATIONAL LOK ADALAT

On 12.9.2015, a monthly National Lok Adalat on Criminal Compoundable matters was held across the State of Haryana. Pre-Lok Adalats were also held to identify suitable cases for settlement in the Lok Adalat. In the said Lok Adalat, 1365 pre-litigation cases as well as pending cases were settled involving an amount of Rs.96,97,750.





JUVENILE TRAINING PROGRAMME FOR POLICE OFFICERS

Police have to act with utmost responsibility while dealing with the juveniles in conflict with law. The police must have complete knowledge about juvenile justice law and the rights of children who come in conflict with the law. Lack of knowledge on the part of police can defeat the very purpose of the enactment on Juvenile Justice.

With this object in view, District Legal Services Authority, Gurgaon organised a training programme for the police officers designated as Juvenile Welfare Officers from each police station in the District Gurgaon. It was organised on 10/9/2015 at the Conference Hall of Commissioner of Police.

Ms. Suruchi Atreja Singh, Chief Judicial Magistrate and Secretary, District Legal Services Authority, Gurgaon explained to the police officers that the objectives of the Juvenile Justice (Care and Protection of Children) Act, 2000, are to ensure the care and protection of children and to provide for their development and rehabilitation. Different aspects of the Juvenile Justice (Care and Protection of Children) Act, 2000, were elaborated quite eloquently. Ms Nazneen Bhasin, Deputy Commissioner of Police, Gurgaon also touched upon the important aspects of the Juvenile Law in her lecture. Ms Dharana Yadav, ACP, Gurgaon, dealt with practical aspects of Juvenile law. A documentary, 'Rise Unto the Last', prepared by Haryana State Legal Services Authority, was also shown to the police officers.



MEDIATION AWARENESS SESSION FOR REFERRAL JUDGES

Referral Judges have an important role to play in Mediation. Referral of suitable cases is prerequisite to promote mediation process as one of the effective modes of alternative dispute resolution mechanism in settling disputes. District Legal Services Authority, Gurgaon, in order to sensitize the referral Judges, organized a session under the guidance of Sh. Harnam Singh Thakur, learned District & Sessions Judge-cum-Chairman, District Legal Services Authority, Gurgaon. It was held on 09.09.2015. In the said session, different aspects of the mediation process, particularly the types of cases which can be referred for mediation were discussed. The judgement given by the Hon'ble Supreme Court in the matter of Afcons Infrastructure limited and another Vs. Cherian Working Construction Company Private Limited and others 2010 (8) SCC 24 was also discussed. The copies of the booklet



published by Haryana State Legal Services Authority on Alternative Dispute Resolution Mechanism were also given to the Judicial Officers.

SPREADING AWARENESS ABOUT THE PERMANENT LOK-ADALAT (PUBLIC UTILITY SERVICES)



On 06.09.2015. Raahgiri Day was held at Gurgaon. A lot of people had gathered on the said occasion. It provided the forum to spread awareness amongst the gathering about the Permanent Lok-Adalat Public Utility Services (PUS). The panel advocates explained to the public about the benefits of Permanent Lok-Adalat. They explained to the public that the disputes with regard to the Public Utility Services

as covered under the Legal Services Authorities Act, 1987 can be filed in the PLA (PUS). No court fee is required to be paid. The public was also informed that in the Permanent Lok-Adalat Public Utility Services (PUS) efforts are made for conciliation. If the conciliation fails then the award is passed. The case is speedily disposed off.

Services Authority Act, 1987 read with the Haryana State Legal Services Authority Rules, 1996.





LEGAL LITERACY CAMP ON "WOMEN PROTECTION AND LEGAL RIGHTS"

A special legal literacy camp was organised at G.D.Goenka Public School for spreading awareness on "Women Protection and Legal Rights" by DLSA Jind. It was emphasised that women occupies a vital position in our society but they are becoming the most vulnerable section as far as their safety and security is concerned. It is very important for the women to know about her constitutional and legal rights. It was mentioned that Article 14 guarantees the right to equality to



women. Article 15(3) allows the state to make special provisions for women and children for their upliftment. Article 39(d) provides for Equal pay for equal work for both men and women. Article 51 A (e) says that it is the duty of the citizens to renounce practices that are derogatory to the dignity of women.

Besides these constitutional provisions, several laws meant for the protection and benefit of women were also highlighted in the said legal awareness camp. It was mentioned that the Dowry



Prohibition Act, 1961 not only penalizes the act of both giving and taking the dowry but also makes the act of demanding dowry an offence. The Hindu Succession Act, 1956 (as amended) was highlighted stating that this Act provided for equal inheritence rights to women for the first time and that it abolishes the concept of limited estate of women. The important provisions of The Medical Termination of Pregnancy Act, 1971, Pre-Conception and Pre-Natal Diagnostic Techniques(PCPNDT) Act, 1994 as well as The Sexual

Harssment of Women at Workplace (Prevention, Prohibition and Redressal)Act, 2013 were also discussed.

The children and senior citizens are vulnerable. Children are voiceless and defenseless. Nurturing children in an environment free from exploitation and fear is very important. Children in Children Homes, Shelter Homes and Observation Homes forms the most vulnerable section. Similarly, Senior Citizens, living in the Old Age Homes, also form the vulnerable section who apart from the legal protection also require the motivation to live happily and fearlessly. To ensure proper legal protection to the vulnerable and marginalized section, the Chairmen cum District and Sessions Judges alongwith Chief Judicial Magistrates cum Secretaries have been making visits regularly every month to Children Homes, Shelter Homes, Observation Homes and Old age homes across the State of Haryana under the instructions and guidance of the Haryana Legal Services Authorities. Short comings are taken up with the concerned authorities. Legal aid is also provided in appropriate cases.

SPECIAL LEGAL LITERACY CAMP ORGANIZED ON HARYANA VICTIM COMPENSATION SCHEME (VCS) 2013




A Special Legal Literacy Camp was organized by the District Legal Services Authority, Jind under the aegis of Haryana State Legal Services Authority on 31/8/2015. It was organized to spread legal awareness with respect to "Haryana Victim Compensation Scheme". The said programme was organized in the DRDA Hall, Jind for officers and officials of District Administration as well as for the Police Department, A detailed knowledge was given

about the relevant provisions under the Code of Criminal Procedure as well as about Haryana Victim Compensation Scheme (VCS) 2013.

It was mentioned that the victims have a right to get justice and remedy the harm suffered as a result of crime. Article 21 of the Constitution guarantees 'right to life', which includes protection of

life and liberty of all members of the society. The expanded meaning attributed to Article 21 of the Constitution by the Hon'ble Supreme Court was also highlighted. It was emphasized that the scheme is formulated to provide funds for purposes of compensation to the victim or his dependants, who have suffered loss or injury as a result of crime and who require rehabilitation.





for their treatment and rehabilitation. The gathering was informed about the eligibility criteria as well as the procedure for grant of compensation. A detailed knowledge was also given about the clauses of the Victim Compensation Scheme, including the right to appeal. The "Schedule-I" attached with the HVCS 2013 was also highlighted stating the maximum limit of compensation that can be awarded in a particular case.

LEGAL AWARENESS CAMP AT TEEJ FAIR

ENSURING EDUCATION OF CHILDREN

Education is critical to reduce poverty and inequality in society. The Constitution (eightysixth Amendment) Act, 2002 inserted Article 21-A in the Constitution of India to provide free and compulsory education of all children in the age group of 6 to 14 years as fundamental right in such a manner as the State may by law determine. The Right of children to Free and Compulsory



Education (RTE) Act, 2009 provides for the elementary education of quality in a formal school which satisfies certain essential norms and standards.

District Legal Services Authority, Palwal has initiated the process to identify children aged between 6-14 who are not getting elementary education. District Legal Services Authority, Palwal has so far identified 250 children who were not going to school. The said children belong to the migrants. District Legal Services Authority, Palwal has taken up the said matter with the education department, and now the process has been started for enrolment of said children in schools.

TRAINING FOR PARA LEGAL VOLUNTEERS

On 31.08.2015, District Legal Services Authority, Gurgaon conducted a training programme for para legal volunteers. In the said programme, Sh. Harnam Singh Thakur, District & Sessions Judge-cum-Chairman, District Legal Services Authority, Gurgaon alongwith Ms. Surchi Atreja explained in detail the role of para legal volunteers. The para legal volunteers were exhorted to discharge their duties sincerely at the grass root level.



SOME RECENT JUDGEMENTS OF THE SUPREME COURT OF INDIA

NO INDIVIDUAL HAS ANY RIGHT TO INVADE ON PHYSICAL FRAME OF ANOTHER IN ANY MANNER.

In Parhlad and Anr., Versus State of Haryana (CRIMINAL APPEAL NO. 983 OF 2015), decided on August 03, 2015, the Hon'ble Supreme Court observed as follows:

An offence of rape is basically an assault on the human rights of a victim. It is an attack on her individuality. It creates an incurable dent in her right and free will and personal sovereignty over the physical frame.

Everyone in any civilised society has to show respect for the other individual and no individual has any right to invade on physical frame of another in any manner.

Dignity of every citizen flows from the fundamental precepts of the equality clause engrafted under Articles 14 and right to life under Article 21 of the Constitution, for they are the "fon juris" of our Constitution.

A CRIME CREATES A DENT IN THE LAW AND ORDER SITUATION.

In Neeru Yadav Versus State of U.P. and Anr. (CRIMINAL APPEAL NO.1272 OF 2015 (@ SLP(Crl) No. 1596 OF 2015), decided on September 29, 2015, the Hon'ble Supreme Court observed as follows:

It is a well settled principle of law that while dealing with an application for grant of bail, it is the duty of the Court to take into consideration certain factors and they basically are, (i) the nature of accusation and the severity of punishment in cases of conviction and the nature of supporting evidence, (ii) reasonable apprehension of tampering with the witnesses for apprehension of threat to the complainant, and (iii) Prima facie satisfaction of the court in support of the charge.

It is an established fact that a crime though committed against an individual, in all cases it does not retain an individual character. It, on occasions and in certain offences, accentuates and causes harm to the society.

A crime, as is understood, creates a dent in the law and order situation. Justice in its conceptual eventuality and connotative expanse engulfs the magnanimity of the sun, the sternness of mountain, the complexity of creation, the simplicity and humility of a saint and the austerity of a Spartan, but it always remains wedded to rule of law absolutely unshaken, unterrified, unperturbed and loyal.
