LAYING OF FOUNDATION STONE OF HARYANA'S EIGHTH DISTRICT ALTERNATIVE DISPUTE RESOLUTION (ADR) CENTER AT AMBALA

Hon'ble Mr. Justice A.K. Sikri, Chief Justice, Punjab and Haryana High Court and Patron-in-Chief, Haryana State Legal Services Authority laid the foundation stone of Haryana's eighth District Alternative Dispute Resolution (ADR) Center at Judicial Courts Complex, Ambala on 3.10.2012 in the gracious presence of Hon'ble Mr.



Justice Jasbir Singh, Judge, Punjab and Haryana High Court-cum-Executive Chairman, Punjab State Legal Services Authority, Hon'ble Mr. Justice Satish Kumar Mittal, Judge, Punjab and Haryana High Court and Executive Chairman, Haryana State Legal Services Authority and Hon'ble Mr. Justice A.N. Jindal, Judge, Punjab and Haryana High Court-cum-Administrative Judge, Ambala Sessions Division.

Address the large gathering comprising of advocates, para-legals and



general public, The Hon'ble Chief Justice disclosed that the concept of opening these ADR centres was to have a permanent single place, where the disputes can be resolved through any of the ADR method by helping people get their disputes settled quickly out of the court. He made an appeal to the gathering to accept the process of mediation and to encourage the same

A model plan of District ADR centre prepared by Architect Department, Haryana has been approved by HALSA.

SEMINAR ON PERMANENT LOK ADALAT FOR PUBLIC UTILITY SERVICES AT FARIDABAD

Hon'ble Mr. Justice A.K. Sikri, Chief Justice, Punjab and Haryana High Court-cum-Patron-in-Chief, Haryana State Legal Services Authority inaugurated a Seminar on Permanent Lok Adalat for Public Utility Services at HUDA Convention Hall, Sector 12, Faridabad on 21.10.2012 in the gracious



presence of Hon'ble Mr. Justice Satish Kumar Mittal, Judge, Punjab and Haryana High Court-cum-Executive Chairman, HALSA and Hon'ble Mr. Justice Hemant Gupta, Judge, Punjab and Haryana High Court-cum-Administrative Judge, Faridabad Sessions Division.

While addressing a large gathering of advocates, representatives of social organisations, Resident Welfare Associations, clubs and general public, it was highlighted by Hon'ble Chief Justice that the purpose of these Permanent Lok Adalats for Public Utility Services was to settle cases pertaining to electricity, water, telephone, insurance, transport, health, housing, banking and finance etc. at the earliest by providing quick settlements out of court, which shall be final. His Lordship urged the legal fraternity to ensure that the faith of public in judiciary as the last bastion of justice is further strengthened and also advised advocates to try to settle various disputes by mediation between both parties or other ADR mechanism including Permanent Lok Adalat (Public Utility Services) before filing the same in court.

On this occasion, revised edition of a booklet titled as "Permanent Lok Adalat (Public Utility Services)" was also released by His Lordship.

Hon'ble Mr. Justice S.K.Mittal disclosed that in Haryana, Permanent Lok Adalats for Public



Utility Services are functioning in six districts, Ambala, Rohtak, Hissar, Gurgaon, Faridabad and Panchkula and that 5 more such Lok Adalats are being set up in districts Bhiwani, Karnal, Rewari, Sonipat and Sirsa very shortly. In such Lok Adalats, matters are settled by way of conciliation without any expenditure at the earliest up to the value of Rupees twenty five lac. He also disclosed that so far, these Lok Adalats have settled 18,959 cases. His Lordship also discussed at length about the concept of "Permanent Lok Adalats for Public Utility Services", Legal Aid Clinics and the Scheme of Para Legal Volunteers.

Hon'ble Mr. Justice Hemant Gupta enlightened the gathering by expressing

his esteemed views about the importance and necessity of Lok Adalats for public utility services, legal services and legal literacy, which are increasing for the last one decade.

Sh. Deepak Gupta, Member Secretary, Haryana State Legal Services Authority highlighted through power point presentation, the idea of setting up of Permanent Lok Adalat (Public Utility Services). A documentary on PLA (PUS) was also shown.

Sh. N.K.Garg, President, District Bar Association, Faridabad in his address ensured full cooperation of bar members for the success of programmes of HALSA.
