Year 2018 marked the achievements and efforts put in by Haryana State Legal Services Authority, when on the National Legal Services Day i.e. on 9th November, 2018 during the commendation ceremony for the best Panel Lawyer, best Para Legal Volunteer, best District Legal Services Authority & State Legal Services Authority, Haryana State Legal Services Authority was declared as the best National Best State Legal Service Authority in India.

The National Legal Services Authority (NALSA) held a Commendation Ceremony at Vigyan Bhawan, Delhi on 15th December, 2018 in collaboration with the Delhi State Legal Services Authority. The event aimed at felicitating the best SLSA, DLSA, Panel Lawyer and Para Legal Volunteer (PLV) in the country. Hon'ble Mr. Ravi Shankar Prasad, Union Minister of Law & Justice and Electronics and Information Technology presided over as the Chief Guest for the programme alongwith other dignitaries namely Hon'ble Mr. Justice Madan B. Lokur, Judge, Supreme Court and



Executive Chairman of NALSA, Hon'ble Mr. Justice A.K. Sikri, Judge, Supreme Court and Chairman of Supreme Court Legal Services Committee (SCLSC), Hon'ble Mr. Justice Rajendra Menon, Chief Justice of Delhi High Court and Patron-in-chief of Delhi State Legal Service

Authority and Hon'ble Mr. Justice S. Ravindra Bhat, Judge, Delhi High Court and Executive Chairman of Delhi State Legal Services Authority.

The award has been a mark of hard work, efforts and dedication put in by all the District Legal Services Authorities, Sub Divisional Legal Services Authorities, Panel Lawyers and Para Legal Volunteers of the Authority in the State of Haryana. The team worked hand in hand to achieve the ultimate goal of "Access to Justice For All."

That apart, Haryana State Legal Services Authority took initiatives for effective management of all legal services clinics, front offices, organizing well-coordinated capacity building training programmes for all stakeholders like panel lawyers, para legal volunteers, CJMs-cum-Secretaries, Mediators etc. and organizing awareness programmes on different social and legal issues.

Additionally, in the North Zone Category the best DLSA was awarded to District Legal Services Authority, Gurugram for the substantial work done through various projects and campaigns on different topics. Its major contribution was digitization of the Front Office in DLSA, Gurugram and first ever medico-legal literacy programme in association with the India Medical Association, Gurugram. That apart, DLSA Gurugram also adopted a focused and strategic approach towards sensitization of stakeholders and for outreaching the public at large. Specific issues of import and concerns were targeted and taken up accordingly. Besides this, the DLSA, Gurugram also mobilized all levels of stakeholders across the Government, Civil Society, Panchayati Raj, Law Universities etc. Youth was also mobilized in providing legal aid and spreading awareness among people.

"THE LIVING STARS" A Campaign for Disabled Children



Despite improvement in the health care system in the country, the situation of differently abled children remains deplorable, particularly in rural areas and among the lower socio-economic population. Differently abled children in India are subject to multiple deprivations and limited opportunities in several dimensions of their lives. Some of these include, not being enrolled to schools,

lower employment rates, limited awareness of entitlements and services available and lack of social welfare support.

In recent years there has been a growing focus on providing education for children with disabilities across the globe. Strong focus on children with disabilities, with a particular emphasis on inclusive education is unprecedented in global discourse and provides a significant opportunity to bring about positive change in the educational lives of children with disabilities and others who are marginalized from and within the education system. These debates are of particular relevance to India given the strong focus on inclusive education in both its national programmes- Sarva Shiksha Abhiyan (SSA) and Rashtriya Madhyamik Shiksha Abhiyan (RMSA). Additionally, in the last decade or so, public discourse around disability has grown in India. However, there continues to be significant lacuna in critical understanding of inclusive education in academic debates.

Keeping in view the need Haryana State Legal Services Authority launched a campaign in the State of Haryana in the month of October and November, 2018 namely "THE LIVING STARS" A Campaign for Disabled Children.

Some of the initiatives undertaken by District Legal Services Authority during the



campaign:

- * Enrollment of disabled children in the schools and vocational institutions
- * Issuance of Disability Certificates in Schools
- * Competitions for Disabled Children in Schools
- * Special awareness camps for issuing disability certificates in villages:
- * Legal awareness camps targeting the victims of violence particularly with disabilities.
- * Special Campaigns for Anganwadi Workers.

SPECIAL LEGAL LITERACY CAMPS ON THE OCCASION OF "WORLD DISABLED DAY"

World Disabled Day is meant to promote rights and well-being of persons with disabilities in all spheres of development and society. The idea is to increase awareness about persons with disabilities, their situation and their means to survive in cultural, economic, social and political life. 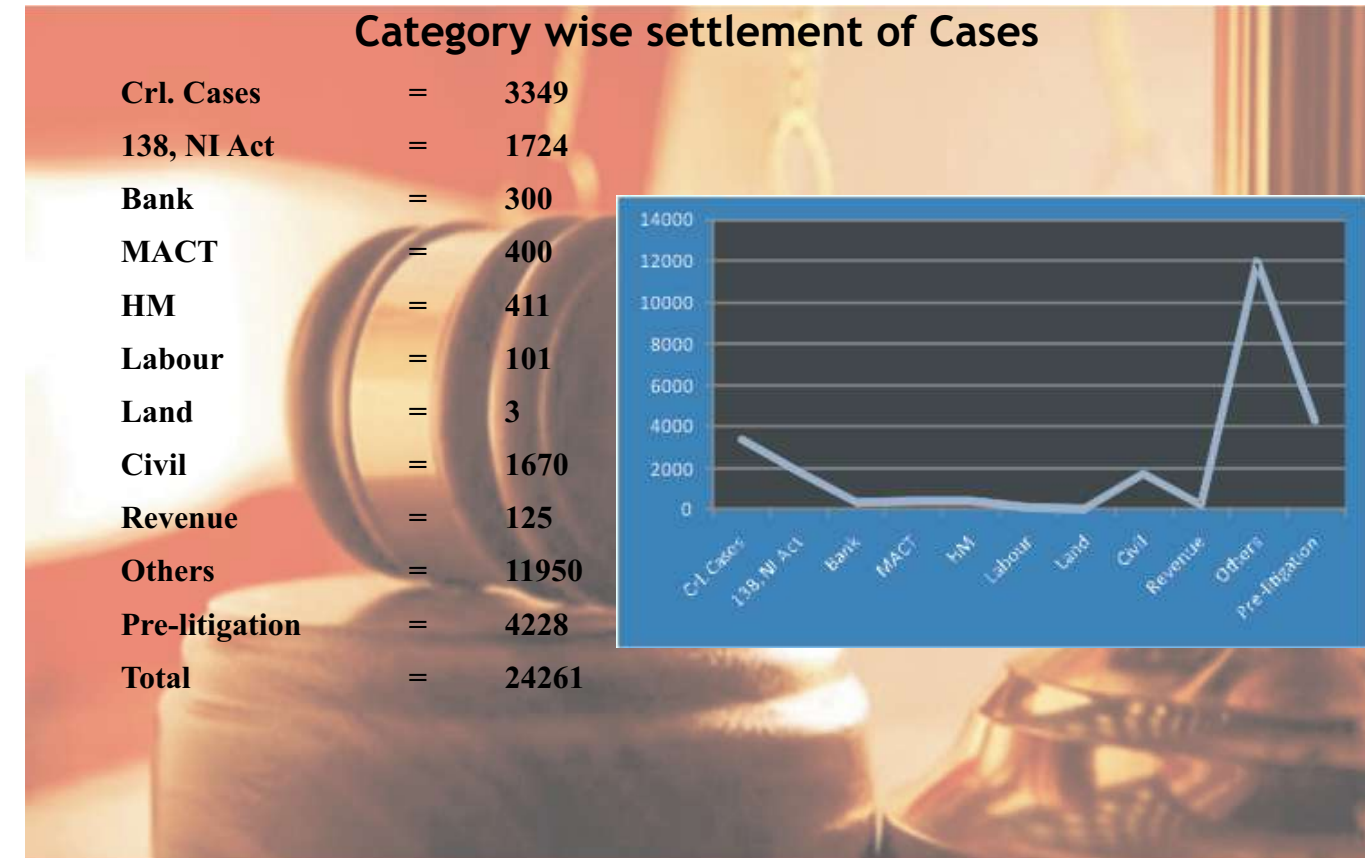
During the year October, 2018 to December, 2018 National Lok Adalats was held on 8.12.2019.

During these visits, they interact with the residents and enquire about their well being. Deficiencies, if found any, are taken up with the concerned authorities immediately.
